The Borough of Lindenwold received your Open Public Records Act (OPRA) request on January 4, 2023. The official Records Custodian received your OPRA request on January 4, 2023. As such, the seven (7) business day deadline to respond to your request is January 13, 2023. The request for clarification because of the following was sent on January 6, 2023.

Your OPRA request sought access to the following:

1. Any and all records including the name "Vance Elder" filed with any police department within Camden County, NJ from January 2018 to the present

Currently, your request fails to identify with reasonable clarity the specific government records sought, as is required by Bent v. Stafford Police Department, 381 N.J.Super. 30, 37 (App. Div. 2005). A request for any and all records is not requesting a specific document. To properly respond, more information is required such as a specific date, address, or other identifiers. Also, Lindenwold can only respond for records within our jurisdiction and not all of Camden County. At this time, we request clarification of your OPRA request. Please respond in writing and identify the specific government records sought so that we may process your request. Failure to provide written clarification of your request will result in the closure of this OPRA request.

The Borough of Lindenwold did not receive a response for the request for clarification. As such, the request is considered closed.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Borough of Lindenwold to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.

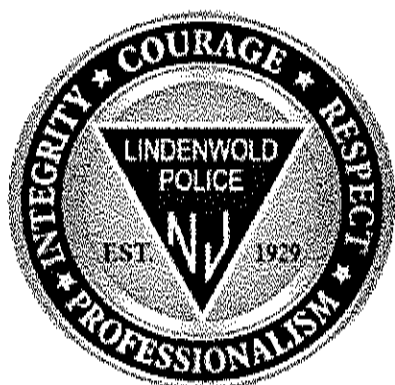

01/03/2023 15:29	On January 03, 2023, at approximately hours, Sarah Vellner came into Lindenwold Police Headquarters to sign complaints against Vance Elder, Sr. for the assault and harassment that occurred January 01, 2023. Sarah provided a written statement and signed the special complaints (Simple Assault: 0422-SC-028231; Harassment: 0422-SC-028233).
01/02/2023 00:23	On 01/01/2023 at approximately 1818hrs, Lindenwold Police were dispatched to the area of the 900 building of Timber Creek Condos for a report of criminal mischief. Upon arrival, the caller, Patricia Connolly, reported that a male, later identified as Jacob Hollis, kicked and hit her Mitsubishi Mirage (NJ# G62PFZ) when she parked it in front of the 900 building (See Case #2023-00040). A witness to the incident, Sarah Vellner, was accompanying Patricia and reported that a male, identified as Vance Elder, assaulted and harassed her while she was recording the incident on her cell phone. Sarah stated that she heard the arguing outside and began recording the incident on her cell phone. When she approached the Mitsubishi, she observed Vance and Jacob yelling at Patricia while she was sitting in her car. She told them to calm down. Vance approached Sarah and told her to "shut the fuck up and go home." Vance then hit her right arm which caused her to drop her cell phone to the ground. Sarah picked up the cell phone and continued to record the incident as Vance yelled at her. Sara did not have any signs of injury and the cell phone did not appear to be damaged. Sara provided the video of the incident which showed Vance walking towards her and knocking the phone out of her hand the video was collected and uploaded to Evidence.com. I spoke with Vance who explained that he exited his apartment after his wife, Ellen Custodio, told him to come outside because of the incident involving Jacob, his son-in-law. Vance said he approached the driver's side of the Mitsubishi Mirage and began arguing with Patricia. While arguing with Patricia, he said that Sarah approached him and put her cell phone in his face and told him that she was recording. Vance admitted to knocking the cell phone out of her hand and walking back to his apartment. Sarah did not sign complaints against Vance at this time.

On January 5, 2023 Patricia Connolly came to police headquarters to sign a harassment complaint against Jacob Hollis. She was accompanied by a witness, Sarah Veltner. According to Sarah, she was outside in her yard when the incident unfolded. She stated that she began recording the incident when she heard the arguing. When asked, she stated that she had already provided her recorded footage to police. According to Patricia, Jacob Hollis accused her of speeding and almost hitting him with her car. She stated that he kicked her car and later returned to hers after she had parked and slammed his fists on top of her car hood demanding to her to exit the vehicle. Furthermore, he approached her side door and tried opening same again telling her to step out. She stated that at this time, her son-in-law came out to which the defendant left the scene.

Patricia provided me with a voluntary written statement documenting same and signed complaint 0422-SC-028390.

On Monday, January 2, 2023, Patricia A Connolly walked into police headquarters requesting to sign a complaint.

Patricia advised me of the criminal mischief that occurred to her white Mitsubishi Mirage (dented hood) on Sunday, January 1, 2023. Special complaint (0422-SC-028337) for criminal mischief was signed against the suspect.

On 01/01/2023 at approximately 1818hrs, Lindenwold Police were dispatched to the area of the 900 building of Timber Creek Condos for a report of criminal mischief. Upon arrival, the caller, Patricia Connelly, reported that a male, later identified as Jacob Hollis, kicked and hit her Mitsubishi Mirage (NJ# G62PFZ) when she parked it in front of the 900 building. It should be noted she was accompanied with Sarah Vellner, who witnessed the incident.

Patricia stated that she was driving in the Timber Creek complex towards the front of the 900 building. While driving, she observed a male crossing the street from the 1200 building towards the 900 building. Patricia said that the male was off to the side and claimed that she did not come close to hitting him. After passing him, she heard him yelling at her.

After she parked her vehicle in front of the 900 building, Jacob and another male, identified as Vance Elder, approached the vehicle and began yelling at her. Patricia remained seated in her vehicle because she was scared to get out. While she was sitting in her vehicle, Jacob kicked her front passenger door and slammed his hands on the hood of her vehicle. She called her son-in-law, Milton Scales, who was inside their residence at unit 909, and asked him to come outside. When Milton exited the apartment, Jacob and Vance walked towards the 1200 building and entered unit 1205.

Sarah stated that she heard the arguing and began recording the incident on her cell phone. When she approached the Mitsubishi, she observed Vance and Jacob yelling at Patricia while she was sitting in her car. She told them to calm down. Vance approached Sarah and told her to "shut the fuck up and go home." Vance then hit her right arm which caused her to drop her cell phone to the ground. Sarah picked up the cell phone and continued to record the incident as Vance yelled at her. Sara did not have any signs of injury and the cell phone did not appear to be damaged. Sara provided the video of the incident which showed Vance walking towards her and knocking the phone out of her hand. The video was collected and uploaded to Evidence.com. (See Case#2023-00055).

I spoke with Jacob and Vance about the incident. Jacob stated that he was walking across the street from the 1200 building towards the 900 building while carrying his children when he observed the Mitsubishi Mirage driving at a high rate of speed toward the 900 building. Jacob claimed that the vehicle drove towards him and then stopped. He felt that the vehicle came very close to hitting him and his children which made him upset so he yelled at the driver. After the children were given to a family member, Jacob approached the vehicle. He said he was angry and slammed his fists onto the hood of the vehicle. Jacob did not want to sign a complaint against Patricia for her driving (See Case# 2023-00056).

Vance explained that he exited his apartment after his wife, Ellen Custodio, told him to come outside because of the incident involving Jacob, his son-in-law. Vance said he immediately exited the apartment, approached the driver's side of the Mitsubishi Mirage, and began arguing with Patricia. Ellen advised that she had a security video from her Ring doorbell. I viewed the footage and observed Jacob crossing the street with his two children. While crossing the street, a vehicle (presumed to be the Mitsubishi) approach Jacob. I was not able to tell how close the vehicle was to Jacob, but I was able to hear Jacob yelling at it. Vance then exited the apartment and ran towards Jacob. The video was collected and uploaded to Evidence.com.

I examined the damage to the Mitsubishi. There was a small dent to the front passenger door and a larger dent to the hood of the Mitsubishi (valued at approximately \$475). The Mitsubishi and damage were photographed and uploaded to Evidence.com.

Patricia did not wish to sign complaints against Vance or Jacob at this time.
