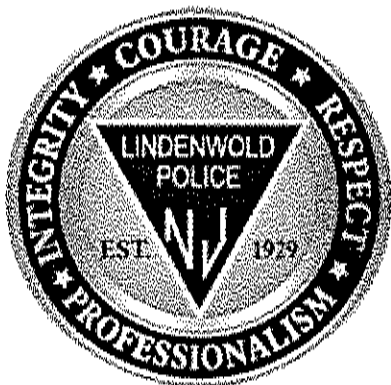
Dear Ms. Jackson,

In response to this OPRA request, we have determined that a special service charge will apply. The request involves 15 separate cases with multiple body worn camera video in some cases. The body worn camera video amounts to approximately 3 1/2 hours of footage. As with all video, our agent must review the entire video and then redact where necessary. We estimate this will take approximately 10 hours of his time along with the hour it took to find each case and determine the amount of video involved. That would be at a cost of his \$21 per hour; therefore, 11 hours X \$21 = \$231. Would you please reach out to the requestor and see if he/she wants to procedure with this project? If so, we will also require an extension of time. Please note we only have one part time employee that is trained to do redactions on the body worn camera video. He is also tasked with all the discovery requests that come in on a daily basis.
