As custodian of records for the Absecon Board of Education ("Board"), I am writing this letter in response to your request for records pursuant to the Open Public Records Act ("OPRA") dated Wednesday, January 22, 2020 at 8:52 pm and received via email on Thursday, January 23, 2020. As such, the seven (7) business day deadline within which the Board is to respond to your request is Friday, January 31, 2020. This response is being provided to you on the 2nd business day after the custodian's receipt of said request.

More specifically, your OPRA request seeks access to the following:

1. Purchase order 19-00904 to Advanced Computer Solutions Group,
2. The invoice from Advanced Computer Solutions Group associated with that purchase order,
3. Any written correspondence between Advanced Computer Solutions Group and the superintendent, business administrator, or their clerical staff, sent or received between January 1, 2019 and December 31, 2019,
4. Any emails between Advanced Computer Solutions Group and the superintendent, business administrator, or their clerical staff, sent or received between January 1, 2019 and December 31, 2019,
5. All invoices from Parker McCay, P.A. from between January 1, 2019 and December 31, 2019.

Based upon the items requested, your request requires additional time beyond the seven business days to fulfill as the district must identify all the responsive documents, retrieve the documents, and redact any non-disclosable/exempt information. The OPRA allows custodians to seek extensions of time pursuant to N.J.S.A. 47:1A-5.i. Specifically, the OPRA states that, "the requestor shall be advised by the custodian when the record can be made available. If the record is not made available by that time, access shall be deemed denied."
