The Ocean County Sheriff's Office received your Open Public Records Act (OPRA) request on or about April 7, 2025. The official Records Custodian, Michael J. Zolezi, received your OPRA request on April 7, 2025.

The following records were requested:

- "I am requesting the radio logs for the Borough of Pine Beach Police Department (1522) for the time period of November 1, 2024 through April 1, 2025."

The following is a line-by-line response to your requested items.

A. Requested records

1. Radio logs for the Pine Beach Police Department from November 1, 2024 through April 1, 2025. **See attached documents.**

OPRA: RIGHT OF APPEAL

If your request for access to a government record has been denied or unfilled within the seven (7) or fourteen (14) business days required by law, you have a right to challenge the decision by the responding agency to deny access. At your option, you may either: 1) institute a proceeding in the Superior Court of New Jersey; or 2) file a complaint with the Government Records Council ("GRC") by completing the Denial of Access Complaint Form. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County. Questions regarding the GRC's Denial of Access Complaint process can be directed to the GRC toll-free telephone at 866-850-0511, by mail at PO Box 819, Trenton, NJ, 08625, by e-mail at Government.Records@dca.nj.gov, or at their web site at www.state.nj.us/grc. The Council can answer general inquiries about OPRA.

The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
