6. Any conversations by any media (phone, text, email, etc.) between the Union City Police Department and the North Bergen Police Department

7. Any conversations by any media (phone, text, email, etc.) between the Union City Police Department and the Hudson County Prosecutor's Office

8. Any reports generated as a result of this incident
