Dear Mr. Kratovil:

This letter shall serve as a response to your request for government records pursuant to the Open Public Records Act ("OPRA") which you submitted to the Garden State Municipal Joint Insurance Fund (the "JIF") on or about April 29, 2025. Specifically, your request sought:

- 1) all signed contract(s) for Rainone Coughlin Minchello (RCM) in effect during 2024.
- 2) all bills/invoices received from the above firm for work done during 2024

(hereinafter the "OPRA Request").

As to the first part of the OPRA Request, the appointment of defense counsel is done through resolution. A copy of Resolution No. 08-24 marked "Response to OPRA Request 011-2025 from Charlie Kratovil - *1" through "Response to OPRA Request 011-2025 from Charlie Kratovil - *6" is enclosed herein.

As to the second part of the OPRA Request, please be advise that N.J.S.A. 47:1A-1.1 expressly defines a government record to exclude certain types of documents. Specifically the provision states:

A government record shall not include the following information which is deemed confidential for the purpose of [OPRA]:

* * * * *

any record within the attorney-client privilege.

* * * * *

information which is a communication between a public agency and its insurance carrier, administrative service organization or risk management office. N.J.S.A. 47:1A-1.1.

The number of invoices which you seek would require an extraordinary amount of time and resources to compile, review, and redact as necessary. Specifically, the JIF will have to review each of the invoices to insure that they do not include any of the confidential information already referenced herein and that any such confidential information be redacted accordingly.

However, in an effort to amicable address the request, enclosed is a report showing the invoices paid to Rainone Coughlin Minchello LLC in 2024 marked "Response to OPRA Request 011-2025 from Charlie Kratovil - *7" through "Response to OPRA Request 011-2025 from Charlie Kratovil - *9."

Please be guided accordingly. The JIF reserves all rights and remedies.
