The Somerset County Park Commission received your Open Public Records Act (OPRA) request on May 20, 2025. This response to your request is being provided to you on the 6th business day after the custodian's receipt of said request.

Records requested:

1) all signed contract(s) for Rainone Coughlin Minchello (RCM) in effect during 2024.
