Dear Cumberland County Prosecutor's Office & Detective David Foote,

We are trying to locate the whereabouts of the cell phone that was confiscated with the Samsung cell phone that is in my name back on December 5, 2022. I have a recorded call with a woman that answered that cell phone in September 2023. She advised me that the office gave her that phone. I'm very confused why a phone that should have been sealed and marked into evidence was given to someone to use as their own personal device.

We also reported that the Samsung cell phone that was returned to us has damage and the SIM card was missing. The forensic investigator states that the phone was in perfect condition and that they put the SIM card back into the phone prior to giving it back to State Police Detective David Foote. Clearly someone from the State Police or the Cumberland County Prosecutor's Office took the SIM card and made the damage to the phone and its case. I am fully aware of the damage that can be done to someone's life by someone having control over their SIM card. Accounts can be broken into, identity can be taken over and criminal acts can be done using that SIM card and making it appear that it was MY husband or me. I see clearly what the plan was. That is why I have been requesting the warrants, the return of the phones, and opra requesting information from State Police and the Prosecutor's Office. Interestingly, State Police have been extremely uncooperative.

It is important that we receive copies of the search warrants associated with these cell phones because State Police never provided a receipt for them as per proper protocol. It's very concerning that these devices were not kept together in evidence. We now need copies of all documentation and logs that you have relating to these two cell phones. All bodycam footage relating to them as well.

The missing phone was only 3 days old when State Police took it on December 5th, 2022. It was not an iPhone yet someone in evidence is telling us that on November 28th, 2023 an iPhone was given as evidence in my husband's case. As you can see that makes no sense.

I find it very disturbing that law enforcement officers would steal our SIM card from one of our devices. Our trust was lost years ago with Assistant Prosecutor Taylor Toscano so our guard has been way up ever since.

My husband has a right to his discovery and the search warrants are a part of "discovery". Please provide those and their supporting documents immediately. We have been beyond patient with you. The carelessness that has been displayed regarding these cell phones warrants a thorough investigation as to what is going on with your departments and their inability to maintain evidence.

Although Jason's defense counsel is still on suspension, I have copied him to keep him informed. He also sees no reason that you would withhold the search warrants/orders. I previously offered to drive to the Prosecutor's Office to view these documents but received no response. Why?

I hope to hear back from you with more information regarding these phones. The confiscation of ones personal property is not for law enforcement officers to hand out to other law enforcement officers. That makes it theft, which you all know is a crime. Looking forward to hearing from you.

Dear Cumberland County Prosecutor's Office & Detective David Foote,

We are trying to locate the whereabouts of the cell phone that was confiscated with the Samsung cell phone that is in my name back on December 5, 2022. I have a recorded call with a woman that answered that cell phone in September 2023. She advised me that the office gave her that phone. I'm very confused why a phone that should have been sealed and marked into evidence was given to someone to use as their own personal device.

We also reported that the Samsung cell phone that was returned to us has damage and the SIM card was missing. The forensic investigator states that the phone was in perfect condition and that they put the SIM card back into the phone prior to giving it back to State Police Detective David Foote. Clearly someone from the State Police or the Cumberland County Prosecutor's Office took the SIM card and made the damage to the phone and its case. I am fully aware of the damage that can be done to someone's life by someone having control over their SIM card. Accounts can be broken into, identity can be taken over and criminal acts can be done using that SIM card and making it appear that it was MY husband or me. I see clearly what the plan was. That is why I have been requesting the warrants, the return of the phones, and am requesting information from State Police and the Prosecutor's Office. Interestingly, State Police have been extremely uncooperative.

It is important that we receive copies of the search warrants associated with these cell phones because State Police never provided a receipt for them as per proper protocol. It's very concerning that these devices were not kept together in evidence. We now need copies of all documentation and logs that you have relating to these two cell phones. All bodycam footage relating to them as well.

The missing phone was only 3 days old when State Police took it on December 5th, 2022. It was not an iPhone yet someone in evidence is telling us that on November 28th, 2023 an iPhone was given as evidence in my husband's case. As you can see that makes no sense.

I find it very disturbing that law enforcement officers would steal our SIM card from one of our devices. Our trust was lost years ago with Assistant Prosecutor Taylor Toscano so our guard has been way up ever since.

My husband has a right to his discovery and the search warrants are a part of "discovery". Please provide those and their supporting documents immediately. We have been beyond patient with you. The carelessness that has been displayed regarding these cell phones warrants a thorough investigation as to what is going on with your departments and their inability to maintain evidence.

Although Jason's defense counsel is still on suspension, I have copied him to keep him informed. He also sees no reason that you would withhold the search warrants/orders. I previously offered to drive to the Prosecutor's Office to view these documents but received no response. Why?

I hope to hear back from you with more information regarding these phones. The confiscation of ones personal property is not for law enforcement officers to hand out to other law enforcement officers. That makes it theft, which you all know is a crime. Looking forward to hearing from you.
