145. Crash Description/Narrative

The driver of vehicle 1 denied he was driving the vehicle. The driver claimed the vehicle was disabled so he was waiting in the driver's seat of the vehicle in the roadway while he waited for his father to bring him a jump box for the vehicle. When questioned on how his vehicle sustained damage to the front and vehicle 2 sustained damage to the rear he advised he is unsure as he was not paying attention.

The driver of vehicle 2 advised she was attempting to stop in traffic on Route 88 at the intersection for Van Zile Rd when the driver of vehicle 1 collided with the rear of her vehicle. The male driver of vehicle 1 immediately exited his vehicle and advised her not to call the police or he would go to jail.

Vehicle 1 sustained damage to the front while vehicle 2 sustained damage to the rear. There were no reported injuries at the time of this report.

During my investigation I observed skid marks throughout the wet pavement and gravel in the roadway leading directly to the resting point where vehicle 1 was located upon my arrival; indicating the location of the accident. At the conclusion of my investigation I find vehicle 1 to be at fault for following too closely.

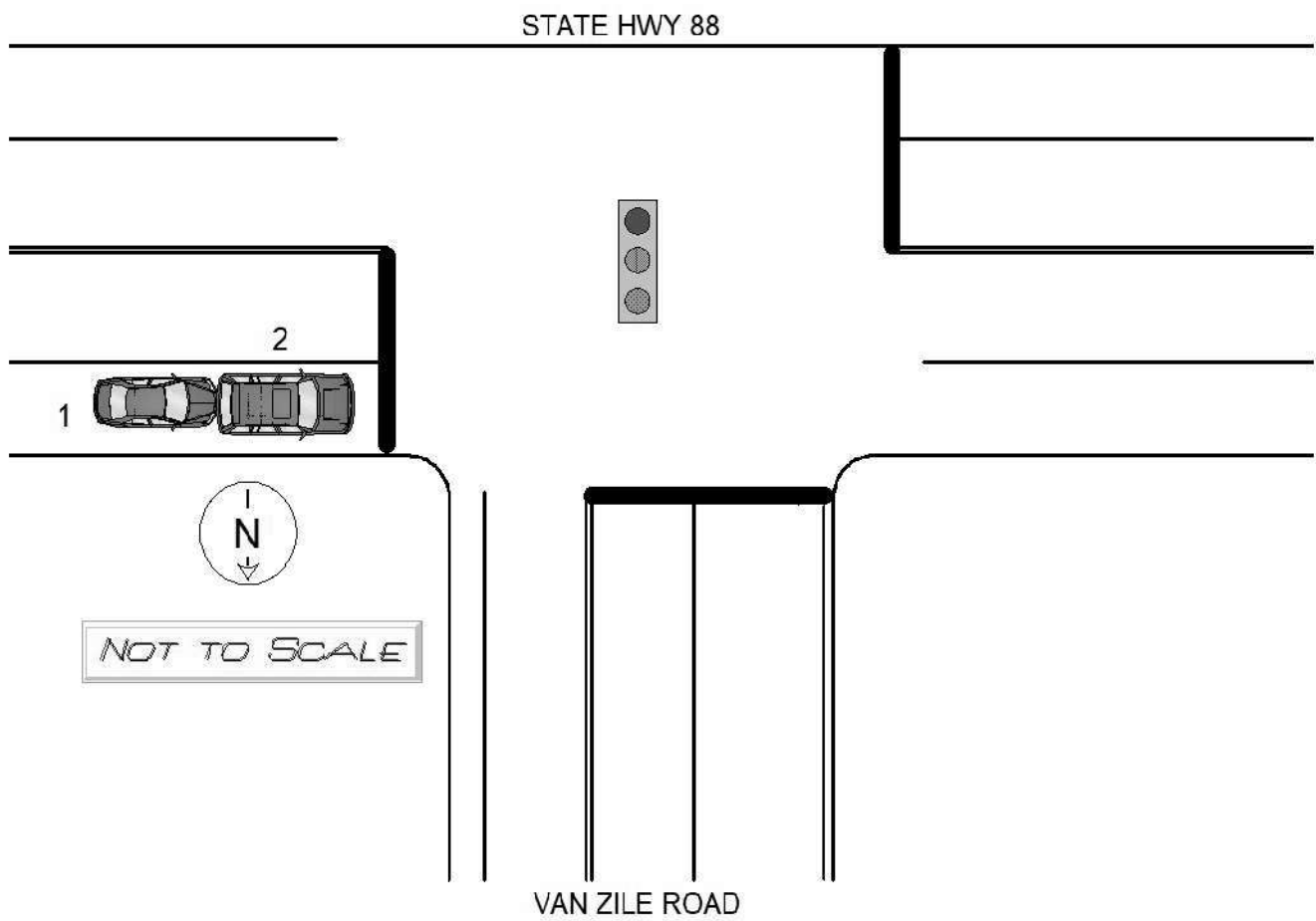
