On August 16, 2020, Daniel Testa was stopped for motor vehicle violations and for being suspected of driving while under the influence. Present in Daniel Testa's vehicle were three juveniles, D.T., M.T., and M.T. Daniel Testa was subsequently arrested for DWI (39:4-50), and transported to Brick Police HQ. At Brick Police HQ, Testa submitted to Alcotest testing. The Alcotest machine indicated that Testa's B.A.C. was .18%.
