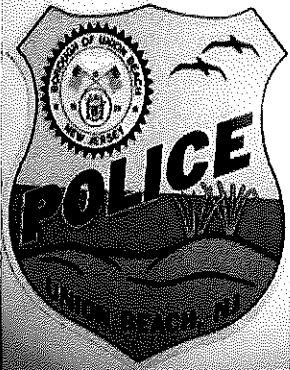

NARRATIVE							
On Saturday June 18th, 2022 at 2118 I, Sgt. Russo, was requested to return to Union Beach Headquarters in response to a phone call from the New Jersey Regional Operations & Intelligence Center (NJ ROIC). The R.O.I.C. serves as New Jersey's primary focal point for information sharing and intelligence production needed to support law enforcement, counter terrorism, and homeland security missions. I returned to Union Beach Headquarters and placed a phone call back to the R.O.I.C., where I was transferred to a civilian analyst, Paul Dailey. Mr. Dailey advised me that the New Jersey Regional Operations & Intelligence Center received intelligence through the cyber-crimes division in regards to the Borough of Union Beach. Mr. Dailey said that their intelligence revealed that at 2100hrs. that evening there would be a pop-up party in the Borough of Union Beach at 916 Eighth St. Mr. Dailey advised me that the cyber-crimes unit intercepted a social media post stating "Party in union beach @9 @dwollner8 916 Eighth St Union Beach, NJ 07735 United States." Mr. Dailey also sent me a photograph of the aforementioned post via e-mail (photograph attached) displaying the above time, date and location. Mr. Dailey informed me that the cyber-crimes unit was able to obtain this information through their own covert social media accounts. It

should be noted that the "post" was displayed on the social media platform "SnapChat" under the story section for an account entitled "JerseyShoreParties". The story which can be viewed publicly by any user (SnapChat currently has 332 Million active users) was displayed in a series of "snaps" which indicated the dates/ times of "pop-up" parties being held in Long Branch, Asbury Park and Neptune City.

After speaking to Mr. Dailey, I immediately went to the address along with Officer O'Toole. As I drove down the street leading up to Eighth St, I observed droves of cars flooding into the area along with over a dozen people on foot and approximately thirty people at the aforementioned address. Having been dispatched to previous calls in surrounding towns with events such as this I was cautious of what was to come. Due to the surge in pop-up parties that resulted in injury to people and damage to property in our area as well as the new reports regarding possible large pop-up parties planned for today. I called all available Union Beach Police officers to come into work to assist. I had our telecommunications officer call the surrounding towns to advise them of the possible situation. I also requested that officers from surrounding towns be dispatched to our headquarters to stage before heading to the scene. The following Police Departments were able to send Officers in response to my request Middletown Police Department, Hazlet Police Department, Keyport Police Department, Holmdel Police Department and the Monmouth County Sherriff Department. Union Beach Police Detective, Deickmann, Officer Woodhead and Officer Kelly were able to respond into headquarters promptly to assist with the situation.

During this time there were approximately thirty people who had arrived at the residence. Vehicles parked illegally on multiple streets throughout town. Officer O'Toole advised that there were approximately 15-20 individuals in the immediate area on foot. Officers were placed surrounding the area to be ready for any possible outcome. Once I felt that we had sufficient help from our neighboring towns and our fellow officers I went to the home to speak to the home owner.

I arrived and spoke to [REDACTED] Age 17) who lived at 916 Eighth St. [REDACTED] told me that he had sent out a private Snap Chat message to all of his friends in his contacts about the party at his house. [REDACTED] told me that he was unaware of the message being sent out to the public. He stressed that he was only looking to have his friends over and no one else. I spoke to his mother Stephanie Wollner, who also indicated she did not know about his party invitation going public. [REDACTED] and his Mother were cooperative and said they would shut down the party. Officers were able to disperse the large crowd without incident. [REDACTED] told me that his message about the party that he placed on Snap Chat was reposted by Jersey Shore Parties. This however is in conflict with [REDACTED] account that the story was private. JerseyShoreParties would only be able to re-post publicly shared stories. The post was taken down by this time. I explained to [REDACTED] and his mother that these unsanctioned gatherings have historically resulted in chaos throughout the state and that these events are synonymous with disorderly conduct, fighting, public consumption of alcohol and property damage which prompt a large police presence.

Officers wrote numerous parking violation summonses on Eighth St and the surrounding area. There were also multiple complaints of fireworks in the area. The home was cleared out and only the family remained inside.
