On 6-6-2010 at 13:31 hours, this officer and Officer L. Miller #262 were dispatched to 41 Coles Way for a report of terroristic threats by phone.

Upon arrival, we met with Avrohom Rothenberg. Rothenberg stated that his answering machine recorded an incoming call to his home phone number, [REDACTED], at approximately 01:30 hours. Rothenberg played the recording in the presence of this officer and Officer L. Miller #262. On the recorded message, the caller told Rothenberg to [REDACTED]

[REDACTED] Rothenberg said that his phone does not have caller ID capabilities so the caller's phone number is unknown at this time and he does not know anyone by the name 'Boris.'

This officer advised Rothenberg to request a copy of his phone bill through Verizon in an attempt to identify the caller's phone number. He was also told to contact this officer through Lakewood PD if he is successful in identifying the phone number. Rothenberg was advised to call Lakewood PD if he received additional threatening phone calls.
