78. Narrative

On Saturday, August 27, 2022, at approximately 1502 hours, the Haddon Township Police Department was dispatched to 4 Wren Road, Audubon Park for a domestic dispute that occurred approximately an hour prior to reporting it. While enroute my body worn camera (BWC #25) was activated.

Upon arrival, I spoke with Danielle Cranmer who stated her boyfriend, Erich Stein, during the course of an verbal argument, grabbed her car keys out of her hands. During the course of the argument Cranmer stated Stein bumped his shoulder into her shoulder while walking past her. Stein gave Cranmer her keys back approximately a minute later and left the residence. Cranmer did not have any visible signs of injury or complaints of pain. Stein was not on scene but was checked for wants and warrants with negative results. The domestic violence registry was checked with negative results. Cranmer stated she did want a temporary restraining order (TRO) and to sign complaints for harassment by offensive touching. Cranmer completed a victim notification form and was given a copy.

Cranmer responded to police headquarters for the completion of complaint and TRO application. BWC #25 deactivated. During the process Cranmer discovered she left her cell phone and left with the intention to return to complete the complaint and TRO. Upon Cranmer returning she again left to get another item she left at the house. Cranmer did not return to the station to complete the criminal complaint or TRO prior to completion of my shift at 1900 hours.

78. Narrative

On August 28, 2022 at 2131 hours, I was dispatched to 4 Wren Road for a removal. While en route, I activated my Body Worn Camera (BWC). Upon my arrival, I spoke with the caller, Danielle Cranmer, who reported that she wanted her ex-boyfriend, Erich Stein, removed from the residence. Cranmer reported that there was a Temporary Restraining Order in effect, but during shift change, I was advised that there was no such order in effect and Cranmer left midway through the application process. (See Case #2022018249 for full incident details). I advised Cranmer of the status of her TRO and she advised that she wanted to reapply. At this time, I escorted Cranmer to Audubon Police Headquarters for the TRO application due to an internet outage at police headquarters. After completing the application, I contacted Municipal Court Judge Krisden McCrink, who after speaking with Cranmer, denied her TRO application. Cranmer was advised of her ability to apply for a De Novo hearing, which she declined, and she advised she would like to retrieve property from 4 Wren Road and stay with a friend. I escorted Cranmer back to 4 Wren Road, conducted the property removal, and she cleared the location without issue. End of call, deactivated BWC.

On September 01, 2022, at 0823 hours, I was dispatched to headquarters for a walk-in, in reference to a restraining order. My Body Worn Camera was activated. Upon arrival, I met with Erich Stein. Stein stated that he responded to Camden County Superior Court and applied for a restraining order against his ex-girlfriend, Danielle Cranmer. The restraining order was granted and Stein advised that his order stated that Cranmer is barred from the residence (FV-04-000739-23). It should be noted, Cranmer applied for and was granted a restraining order against Stein on August 30, 2022, barring him from the residence (FV-04-000732-23). Stein was escorted off of the premises due to the order. Contact was made with Camden County Domestic Violence Probation Officer, Diego Vera. He reviewed both orders and both audio statements at the time of the application. Vera stated that in Cranmer's order, Superior Court Judge DiCamillo granted her exclusive possession of the residence, 4 Wren Road in Audubon Park, until the court date hearing. Stein was made aware of my findings and an amended order was served to him. While reviewing the amended order with Stein, I noticed on page 4 of his order a warrant to seize weapons for safekeeping was completed. I advised him that we would respond to the residence and take possession of her personal pocket knife. On this date, at approximately 1100 hours, I responded to 4 Wren Road and spoke with Cranmer. She was served with Stein's restraining order and she was made aware of the warrant to seize her pocket knife. Cranmer complied and removed from her dress a rainbow colored Kershaw pocket knife. The knife was transported to headquarters and logged as safe keeping. The New Jersey Court System was updated for service for both orders. No further action was taken at this time. 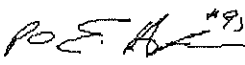
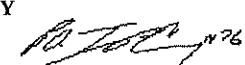
