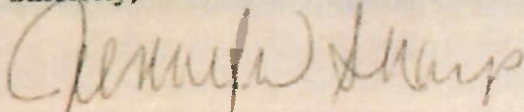
Dear Mr. Malik:

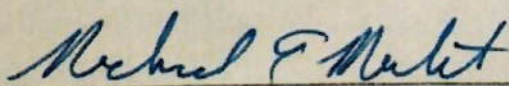

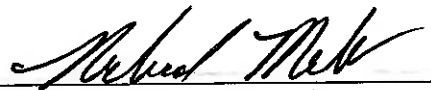
