I noticed that it started at 9:30 AM and I noticed that a lot of the volunteers are still at the building sleeping. I asked my supervisor Christina Lowe if she knew of the volunteers are supposed to be taking part in the frost on the pumpkin standby as they have in several years in the past. She told me she was not sure if they were being involved this year and to ask dispatch. At that time I saw patrolman Keith Barry driving around and I asked him if he knew if the volunteers are supposed be participating in this event today. He told me he was not sure and asked if they were inside and I did tell him yes they were asleep. Keith Barry did state that they have done this in the past and he is not understand why they wouldn't be doing it this year. Shortly after my conversation with the officer Keith Barry I received a phone call from dispatch asking if the volunteers are partaking in the frost on the pumpkin event. I advised dispatch that me and my partner and I would standby at the building follow and the trailing runners to the end of the 5K race. At this point I also informed South River Police dispatch that I will get in contact with the captain and see if he's for taking in the event. I asked Patrick to her all those south of rescue squad captain what is his pleasure if you would like to pay Ems to handle the event today or if he's going to also have the volunteers per taking it. I called dispatch and told then that Southriver Ems was going to stand by the building and follow the trailing runners of the 5K race. Dispatch also informed me that they were going to put atone for line from the volunteers are the contact communications. I could hear over the radio from the dispatch room that they were not happy that the volunteers were not present in there he were requesting that they be present at this event. Myself and my partner poem ambulance 547 out on the pad and begin the standby for the frost on the pumpkin rice. About 10 minutes later the volunteers came out and pull units 548 with Pat And Rob, units 542 had Jeremiah and it did that by the name of Gabby, also present was Ambulance 544 which had a Edina and Javier. Ambulance 547 stayed on location until the last of the runners for cross the finish line and then shortly after cleared and return back to the station.

Note I know this does not have anything to do with the events are occurred yesterday. However I'd like to make it known that last Saturday was South River high school's homecoming football game. Which the volunteers not partake in the homecoming parade. While myself and my partner on a call about 1215 to 1220 in the afternoon patrolman Kline asked me on the side why did the volunteers not partake in the homecoming parade. I found that question be extremely difficult to answer and I also felt very embarrassed that the volunteers not take part in the parade and did not notify the paid EMS about the parade either. As long as I've been employed at Southriver him as a volunteers have always been taking part of town events and never blew them off I've noticed over the past few months a lot of events whether it be high school football games or just a simple parade.

Hello everyone. As all of you should know by now, I was elected President for 2018. I know most of you know nothing about me. Since I joined the squad in 2008, I've mostly only ridden my duty night, and occasionally participated in other events and rode an extra night a couple times here and there. Therefore, I'd like to introduce myself and share a little bit of my background with you.

I first started volunteering in August 1986 at the age of 16 and I became an EMT in January 1987. After being a volunteer EMT for 5 years, I entered US Army Basic training in January 1992. While in the Army, my EMT card expired. Nine years after joining the Army, in 2001, I became an EMT again. I rode with two different first aid squads from 2001 until I moved to South River in 2008. In 2006, I was hired by the Brick Township Police Department as an EMT. I now have over 11 years on the job with Brick. Brick is quite different from South River. We average 25 calls a day and have 3 ambulances on duty during the daytime hours. Needless to say I have a wide range of experience when it comes to EMS calls due to my job in Brick.

Although I've never been a line officer or executive officer of a squad, I do have my share of leadership experience. In the Army I was an MP and as a Corporal and then as a Sergeant I was in charge of soldiers and I was a shift supervisor. Additionally, I am the Scoutmaster for South River's Boy Scout troop 83. Without much experience in scouting, I took the job of Scoutmaster and did everything I needed to learn the job and I like to think I've done well in a position I hadn't expected to have, much like the President position I now hold.

My goal for 2018 is to help the squad improve itself by improving communications, morale and reliability of the volunteers. My immediate goal will be to help strengthen our duty crew commitments. I understand some nights are being covered solely by our paid staff while other nights are split crews and some crews won't respond to calls until after midnight while other crews are going off duty before 6am. This is all unacceptable to me.

I have some ideas that I want to present to the squad at our first meeting that I hope will lead to us getting more of a commitment from our members. A longer term goal which I'd like to achieve by the end of 2018 is to build crews that are willing to ride every Saturday and Sunday evening from 6p - 11p, removing our dependency on the paid staff during those hours. I feel this is vital for the growth of our squad, as it will allow cadets and new adult members to spend time riding and learning from experienced volunteer members during a time that they are more likely to be available, on the weekends.

An even longer term goal, and one I'd be ecstatic to see achieved in 2018, would be to return the daily 6p - 11p time slot to the volunteers, with dedicated crews staffing the ambulances during those hours.

All of this can only be achieved through the cooperation of the line officers and the general membership. I hope I can count on you to do your part and help rebuild what we have left of the squad. Please make every effort to attend the first meeting of 2018, which should be January 4th. Remember, you get a call credit just

My partner Brendan Amos told me that one of the cadets Gabby was intoxicated and was falling off of 548. How he found this out was a member by the name of the edina said to her how are you feeling. Also a another member by the name of Jeremiah said do you remember anything that occurred last night. Patrick did make a comment saying that she wanted to drink or night away to forget and boy did she do that. I told my partner that he needed to contact director Christina Lowe to them for more of what he was told. Later on that night Javier made a comment that he was drinking. When I asked him if he was drinking he immediately change the subject and said he was not. I told him that he needs to be honest and if there was anyone drinking my water they on the ambulance. He said no one that was drinking was on the ambulance. He said he only one that was drinking with Gabby and she did not step foot on the ambulance. I find this to be extremely inappropriate for the captain of the squad Patrick to make a comment that she wanted a drink or a night away and boy did she do that in the general public while outside in the public eye. I also find it extremely disturbing that they are allowing underage drinking to be taking part either off locations or at the squad and allowing them to come back to the building.

Preceptors your job is to train your observer and aid them in passing this test. Show them how to do a rig check, enter info in EMS charts mobile and add in all information to the IRS. All:

Due to most of you refusing to do your jobs for most of this year, South River EMS and the South River Rescue Squad find themselves in the position of being non-functioning agencies.

Your refusal to attend required meetings (SREMS or SRRS) since March, and to sign vouchers or cut checks despite repeated requests to do so, makes it nearly impossible to pay our bills on time (if at all) or conduct business necessary to legally run a company. It is foolish shortsightedness to continue with what appears to be a year-long temper tantrum that is severely damaging both organizations.

Due to the situation we find ourselves in, I have contacted Richard Braslow as the attorney for both agencies. I have been advised that in addition to it being difficult to do business in this manner, it is illegal for us to even try, and steps need to be taken to either fix the problem or disband the agencies.

Our next regular meetings are scheduled for Thursday, 7/6. If we fail to have these meeting and take care of business, I will have no choice but to notify the Borough of South River and any other relevant authorities that South River EMS and the South River Rescue Squad no longer exist as viable agencies.

The choice is yours.

At around 2003 hours on May 17th 2018 SREMS was dispatched for a fire stand by at 63 Devoe Street request by Fire command. Upon arrival SR Fire Department was already on location and reported that they found a heavy smoke condition coming from the basement windows. Turns out it was a stove fire that SR Fire put out before 547 arrival. 547 staged in the area requested by fire command. Fire command reports that they will not need rehab and it was not requested. At around 2020 hours 501 got on the radio reported that he would be responding to the building and bringing the trailer. I advised 501 via Phone at 2021 hours that there is not additional man power requested and that rehab is not needed I also advised 501 that fire was not on any air and did not have any lines connected that where active and advised him that we have it under control. At about 2040 hours Rescue 5 arrived along with 545. The rescue squad member that attended where Patrick G, Edina S, Mathew P, Ashley V, Andrew C. 501 established EMS Branch. All EMS united where cleared by fire command at 2053 hours. Upon clearing the scene 545 was found to be extremely far distance away to the point of it being almost unusable being almost three blocks away. My concern over this entire event is that this is a complete miss use of units that had no need for their appearance on this scene rather would have made more sense to use the five members to stand by at the building to provide coverage for the town in the event of a second call using the two Ambulances that the building.
