I appreciate your consideration of the following matter. Under OPRA and the Common Law Right of Access, I am requesting a current list of records for each of the following be delivered via e-mail:

- 1) All abandoned/vacant residential properties (Property Class 2) *ATTACHED*
- 2) All condemned properties - *NO RECORD MATCHING REQUEST*
- 3) All residential properties with delinquent taxes *ATTACHED*
- 4) All residential properties for which a Lis Pendens notice has been filed or that are currently in probate *NO RECORD MATCHING REQUEST*
- 5) All properties that are absentee-owned *NO RECORD MATCHING REQUEST*
- 6) All properties with delinquent water and sewer which date back up to 1 year, including amounts owed *SEWER ATTACHED*
- 7) All properties currently listed with water shut-off notice - *NO RECORD MATCHING REQUEST*
- 8) All properties with code violations, including the type of violation - *NO RECORD MATCHING REQUEST*
- 9) All properties with notices of abatement *NO RECORD MATCHING REQUEST*
