OFFICER REPORT NARRATIVE

On the above date and time - while on Patrol in Marked Unit #5, Officer Meehan (722) and myself observed NJ REG - L22JNG drive thru a red light at Green St and Route 27 in violation of NJSA 39:4-105. Officers activated the overhead lights of the patrol vehicle and conducted a Motor Vehicle stop on Oak Tree Road & Middlesex Ave. The driver and sole occupant of the vehicle was identified as (D) Eric Magazine, he was advised on the reason for the stop in which he stated, "I really have to shit, I'm sorry". Eric then produced an NJ DL, that was subsequently ran all around by WPD Dispatch for wants and warrants. WPD Dispatch advised us that Eric had three (3) warrants as follows:

- 1) North Plainfield - E25 007584/ \$550 10% option/ Judge Taddeo
- 2) Newark - E17 114815/ \$650/ Full Bail/ Judge Williams
- 3) Garwood Boro - E25 002326/ \$750/ Full Bail/ Judge Bundy

Eric was advised on the following warrants, ordered out of his vehicle, handcuffed (double-locked) searched, and placed into the rear of Marked Unit #5. He was transported to WPD Headquarters, where he was booked and processed accordingly. Officer Meehan completed an ROR Form for North Plainfield's warrant. Newark and Garwood jurisdictions Released on Recognizance, and Eric was released without incident.
