Dear FratLawz:

The Borough of Glassboro Records Custodian received your request for records pursuant to the Open Public Records Act (OPRA) and the New Jersey common law right of access, dated March 18, 2023, via email on March 20, 2023, and forwarded your request to the Police Records Sub-Custodian for a response as to Items 2 and 3 for police records. Accordingly, the initial seven (7) business day deadline to respond to your request under OPRA was March 29, 2023. By correspondence dated March 27, 2023 we provided our response to your request via email to the address from which you sent your original request.

By email dated March 27, 2023, before awaiting our response within the seven (7) business day deadline to respond to your request, you replied as follows to the Borough of Glassboro Records Custodian:

I was attempting to gain information relating to an incident on March 4th, 2023 at 18 N. Academy Street (Glassboro) as seen in my initial request letter (also attached), you informed me there were no such incidents available for this date and time and believe this may of been some sort of mistake. I am someone who lives in this neighborhood and witnessed the Police and Fire Department arrive on scene at this address to a large scale party and issued numerous citations as confirmed by Police and Fire personnel I asked as a interested citizen due to the loud noise, there were also multiple municipal citations issued at the scene which I assume would have reports for).

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Borough of Glassboro to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
