NARRATIVE On 08/11/2019 at approximately 1745 hours, while in uniform patrol, I responded to 171 S. Thoreau Terrace for a dog bite. Upon arrival, the patient Jodi Wozniak was already on board with EMS and paramedics. EMS advised me they needed to urgently transport Jodi to Wrangelboro Park to be flown to Cooper Hospital in Camden. When I made contact with witness's on scene they advised the dog was locked in the cage. Kierstin Cassel and Jared Taylor advised that Jodi bought a new full grown brown and black German Shepard yesterday in Philadelphia. Jared advised today everyone was upstairs when the attack took place. Jared advised he heard screaming from Jodi and ran downstairs immediately, when he observed Jodi covered in blood leaning up against the dog cage. Jared and Kiersten stated the

dog was growling viciously attempting to get out of the cage. They were able to lock the cage and call 9-1-1.

I was unable to get statement from Jodi at this time on the incident. Animal control arrived on scene and took the German Shepard. Paramedics advised the dog bit Jodi's right hand (full/ partial amputation), left forearm (down to the bone), right forearm (down to the bone), left bicep (double puncture), and the left calf (double puncture). Notice of bite form was completed and faxed to Atlantic County Board of Health Department. Sunrise Bay HOA was contacted and advised of the incident.
