NARRATIVE

On 08/28/2019, patrol units were dispatched to 171 South Thoreau Terrace for an animal complaint. The caller advised dispatch that he heard a dog yelping and someone throwing water on the dog at the rear of the residence. When I arrived on location, I was met by Jodi Wozniak. At first, Jodi stated that nothing occurred and that she had forgotten that her German Shepard was leashed to a tree out front. Soon after, Jared Taylor walked out of the residence and got into a vehicle that belongs to Jodi. Officer Lopez #105 saw that Jared had his right arm wrapped in a towel. Officer Lopez questioned Jared, who stated that he was bitten by one of Jodi's dogs.

three-year-old Border Collie. Jared stated that Haze's leash got tangled in a tree. While attempting to untangle Haze, Jared was bitten in the right arm and hand. Jared stated that he had to grab Haze by the neck to free himself. Jared refused any medical assistance. Jodi was advised that she would have to keep Haze confined for at least ten days and that The Atlantic County Health Department would be contacting her about the incident. Officer Lopez checked on Haze, who was secured in a cage, and he appeared to be uninjured. Jodi provided documentation that Haze had a rabies shot in May of 2019.

An animal bite form was completed and faxed to the county.
