NARRATIVE

On Tuesday, September 10th, 2019, I, Officer Cantona #131, responded to **199 S. Thoreau** for a report of an animal complaint. Dispatch advised that two large dogs described as German Shepard Belgian Malinoises ran into the woods.

Upon arrival, I spoke with the caller. He stated that his wife and he last saw the dogs behind their home. While circulating in the area, an unknown area resident stated that the dogs belonged to a female residing at **171 S. Thoreau**. At that time, I responded to 171 S. Thoreau where I met with the Maintenance Manager later identified as **Robert Moran**. Mr. Moran confirmed that the dogs belonged to that house (171 S. Thoreau) and stated that this was an ongoing issues regarding her dogs and an eviction process in place within the management. I made contact with the dog owner who was later identified as **Jodi L. Wozniak** DOB [REDACTED].

While speaking with Jodi, she initially stated that the dogs did not belong to her, and she only had three dogs at her home. Moments later, the brown / black color dog (German Shepard) ran passed the rear of my patrol vehicle. I asked Jodi about the dog again which she insisted that the dog did not belong to her. While on scene, Mr. Moran informed me that Jodi took the dog in from the back of the house. I spoke with Jodi again about the dog at which time she verbally admitted that the dog did belong to her. Ultimately, Jodi was issued municipal summon for ordinance violation for **Dog Running At Large Ticket # SC 014946**. All of the dogs were secured in Jodi's house, and no injuries were reported.
