145. Crash Description/Narrative

This accident occurred on Washington Road at the entrance to Rite Aid. D1 stated that he was driving behind V2 when he attempted to change into the right lane. D1 stated that there was another vehicle in his way and he was unable to brake in time to avoid collision with V2. D2 stated that she was stopped waiting to turn into Rite Aid when V1 attempted to pass V2 on the left and collided with V2. Passenger 2 had complaints of pain in her head. JFK EMS arrived on scene and evaluated D1, D2 and P2. All individuals refused further medical attention. D1 was issued summons #E20002561 for 39:4-97 Careless Driving.

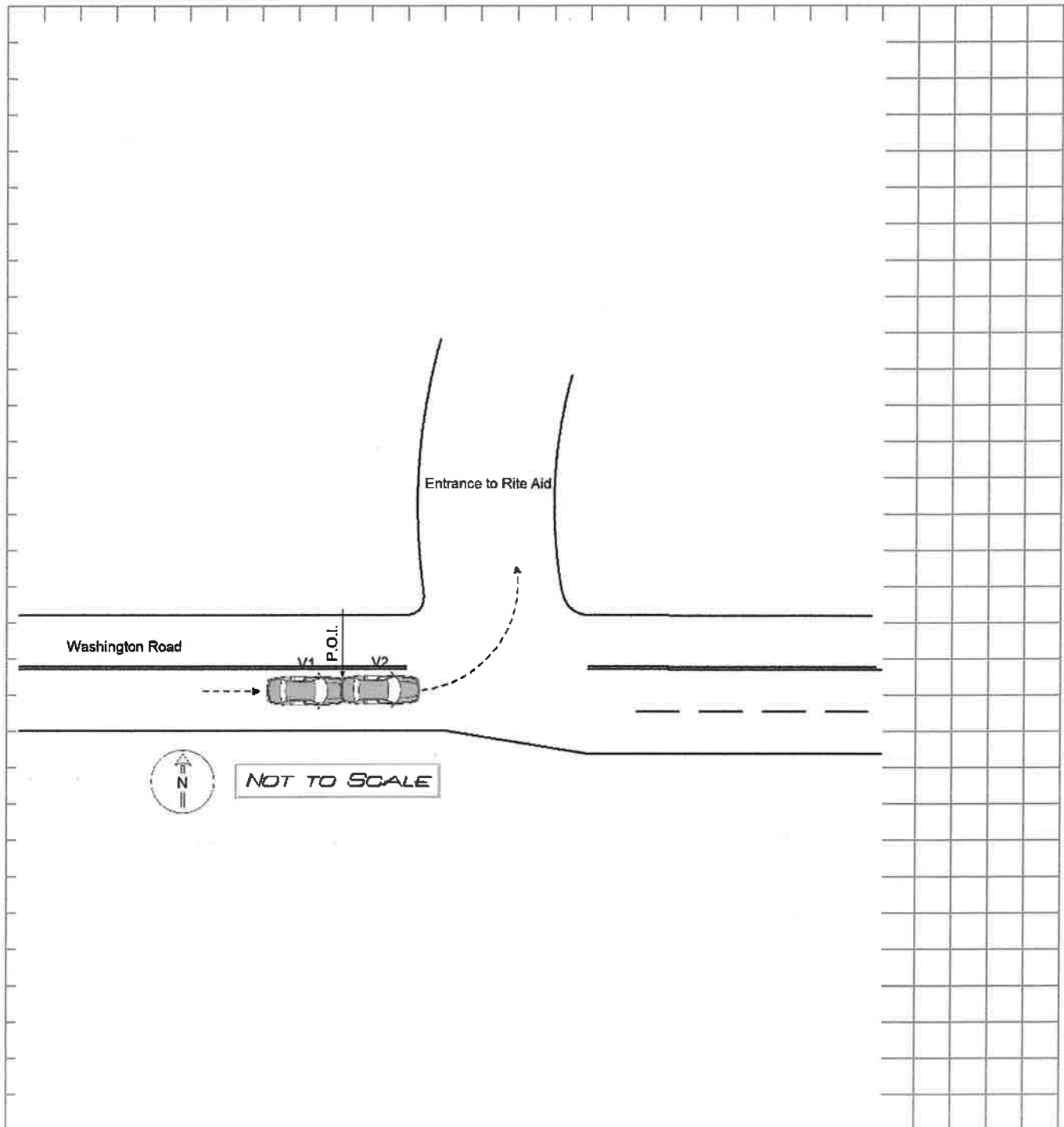
