**AWARDING CONTRACT FOR FIRE TRUCK

WHEREAS, the Mayor and Council finds that it is in the best interests of the Borough of Norwood that a contract be awarded to the bidder in accordance with the terms of the specifications; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available and the certification is attached; and

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Norwood that:

1. The contract for the above-referenced purchase is awarded to Seagrave Fire Apparatus, LLC, 105 East 12th Street, Clintonville, WI 54929, at the bid price of \$769,350 for the labor and materials as set forth in the specifications;
2. The Borough Attorney is authorized and directed to prepare a contract for these purposes:
3. The Mayor is hereby authorized and directed to execute, and the Borough Clerk to attest, a contract to carry out the foregoing purposes in accordance with the specifications in a form prepared by the Borough Attorney;
4. The Borough Clerk is authorized and directed to hold the certified checks and/or bid bond of the bidder until the Borough receives a fully executed contract and all other required documents from the successful bidder; and
5. A copy of this resolution will be submitted to the bidder, and a copy will be kept on file in the Borough Clerk's office for public inspection during regular business hours.

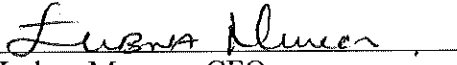
