To All Paid Division Members:

As you are aware, the Neptune Township Fire District #1 has adopted a local fire mutual aid plan in accordance with N.J.A.C. 5:75A-2.2. Pursuant to that mutual aid plan, the NTFD is obligated to dispatch aid in the event of activation of that plan by the Monmouth County Communications Center. Activation requires that the County Dispatch notify the Chief of the requested department and that the Chief then dispatches the requested equipment and personnel as appropriate.

Last year, it was determined in coordination with the Asbury Park Fire Department that the Paid Division would not respond to mutual aid requests from Asbury Park when volunteer personnel can be made otherwise available. The Commissioners wish to make it clear that this procedure is to ensure that the Township of Neptune has, at all necessary times, the availability of its Paid Division to service the citizens of Neptune Township. We have notified the surrounding townships about the procedure that we have in place and expect that they will respect that procedure when requesting mutual aid.

In the event that the procedure is not followed, under no circumstances are the Paid Division to respond to direct aid calls from any other municipality. Rather, if those requests are made directly to the Paid Division, the procedure is to immediately notify the Chief of the Department of the request so that the appropriate personnel can then be dispatched.
