REPORT OF INVESTIGATION

TITLE: Possession and Distribution of Child Pornography

DATE OF REPORT: 06/09/2021

SYNOPSIS: Investigation regarding Possession and Distribution of Child Pornography.

DETAILS:

On May 5, 2021, I assisted Detective Sgt Hill of the Ocean County Prosecutor's Office High Tech Crime by conducting surveillance of the residence located at 254 Lakewood Road Unit 229 New Egypt, New Jersey 08533. I photographed the residence, along with two vehicles that were parked in the driveway of the residence. I conducted a New Jersey Motor Vehicle inquiry of the vehicles identified by their registrations numbers as:

On June 2, 2021, Honorable Guy P. Ryan, J.S.C. was provided and approved a search warrant for 254 Lakewood Road Unit 229 New Egypt, New Jersey 08533.

On June 9, 2021 at approximately 0625 hours, I Detective Anthony Ringle, Sgt Hill, Detective Dotto, Detective Mantle, Det Coles, Detective of the Ocean County Prosecutors Office High Tech Crimes Unit and Special Agent of Homeland Security arrived at 254 Lakewood Road Unit 229 to execute a search warrant for evidence pertaining to the possession and distribution of child pornography.

Upon arrival, Sgt Hill and I approached the front side door of Unit 229 executing a "Knock and Announce Search Warrant. An elderly white female answered the door, we advised that we had a search warrant for the residence. Sgt Hill asked the elderly female if the suspect identified as Richard Knight, was home. The female stated that her daughter identified as Sandra Knight drives him to work every morning. The female stated that they left a little while prior to our arrival. When the female was asked where Richard Knight worked, she stated that he was working at his boss's house "John" in Brick.

When making entry to the residence detectives were overwhelmed by the smell coming from the residence. During the search it was found that 2 children, ages 10 and 16, were living in the residence along with 3 adults, 2 cats, a dog, a pig and some type of reptile. All of the animals appear to utilize the indoors for their bathroom habits. This was in a 2-bedroom single wide trailer. Sgt. Hill would be notifying DCP&P, when the search warrant is complete.

At this time, Sgt Schaal, Detective Dotto, Detective Mantle, Det Coles, Detective of the Ocean County Prosecutors Office High Tech Crimes Unit and Special Agent of Homeland Security continued to collect evidence at unit 229. Sgt Hill and I were enroute to Brick to attempt to locate Richard Knight at >>>>. While enroute, I received a phone call from Sgt Schaal advising that Sandra Knight had returned to Unit 229, advising that she had dropped Richard Knight off at 154 Juliustown Road in Browns Mills. At this time, Sgt Hill and I redirected to 154 Juliustown Road in Browns Mills. At the time, of search warrant, Ocean County Prosecutor's Office High Tech Crime Squad collected, photographed and seized two cell phones, then transported to Ocean County Prosecutor's Office High Tech Crime Squad Forensic Laboratory. All of the digital electronic evidence are pending a forensic examination.

Upon arrival, we located Richard Knight escorting him to Sgt Hill's unmarked patrol vehicle. Sgt Hill advised Richard Knight that he was being placed under arrest for Possession and distribution of child pornography. Sgt Hill placed handcuffs on Richard Knight utilizing the double locking mechanism. Ricard Knight was searched for any weapons or contraband, with negative results. Richard Knight's personal belongings were removed and placed into an evidence bag for transport. I assisted Mr. Knight securing him in the rear seat with a seat belt in the unmarked patrol vehicle. Sgt Hill and I transported Richard Knight to Plumsted Police Department to be processes and interviewed.

Upon arrival, I assisted Richard Knight out of the rear of the unmarked patrol vehicle, escorting him into Plumsted Police Headquarter processing room. Once in the processing room, I searched Richard Knight for any weapons or contraband with negative results. I removed the handcuffs and secured Richard Knight to the processing room bench via ankle cuff. I then removed my duty weapon securing it in the armory room during processing. I began to document all of Richard Knight's personal property on a Plumsted Police Prisoner Property report, then Richard Knight signed. Once completed, I removed the ankle cuff then escorted Richard Knight into the interview room.

Once the interview with Richard Knight was complete, Richard Knight was escorted back to the processing room. Richard Knight was fingerprinted and photographed, then secured to the processing room bench. I then served Richard Knight his copy of the charges advising that he would be lodged in Ocean County Jail pending his hearing. Richard Knight requested a phone call to his wife Sandra Knight, which he was granted. Richard Knight requested that his wife was on her way to take possession of his property. I advised that his property will be secured until her arrival. Once all the needed paperwork and reports were completed, I removed the ankle cuff from Richard Knight. I placed a transport handcuff belt on Richard Knight placing the handcuff in the front position, utilizing the double locking mechanism. I escorted Richard Knight to my unmarked patrol vehicle assisting him in the rear seat securing Richard Knight with a seat belt. I advised County dispatch my starting and ending mileage to Ocean County Jail. Upon arrival, Richard Knight and his copy of his charged were turned over to the possession of Ocean County Jail to be lodged.

Two charges were approved for Richard A. Knight (D.O.B. 05/11/1981) to include:

1 Count of Distribution of Child Pornography - 2C:24-4B(5)(A) - a Second Degree Charge.

1 Count of Possession of Child Pornography - 2C:24-4b(5)(b)iii a Third-Degree Charge.

Additional charges are pending forensic examination.
