ACTION TAKEN Ms. Ullrich (Activities Director, Ridgecrest Senior Apartments) stated that two residents approached her yesterday and advised her they wanted to speak to her about something that was concerning them. She reported that the two residents, who wished to remain anonymous, advised her that about eight or nine days ago at around 1700hrs, they observed a white vehicle (no further description) enter the parking lot. The vehicle parked and three white teenaged males exited with a large case. The teens walked around the parking lot and eventually opened the case. They then pulled out an "AK-47" type gun. The teens began to shoot into the wooded area by Upper Blvd. A train came about 15 minutes later and the teens got in their car and left the area. Ms. Ullrich stated that the residents saw this from the garden patio which is elevated above the parking lot area. It was believed by the staff that the "Ak-47" was an airsoft gun, however they wanted to document the incident. They were going to attempt to review the surveillance footage and will contact this agency if they are able to find anything.
