On 09/29/2021 at approximately 2102 hours, I responded to the area of 1390 Route 9 for a report of a civil matter. While en route to the above location TR Communications advised that the involved female was now at 1685 Route 9, Rita's and was possibly stabbed. I then responded to that location and spoke with victim, [REDACTED] who reported the following.

Upon speaking with [REDACTED] she advised that she was not stabbed and there was no stabbing attempt. [REDACTED] did, however, have superficial lacerations to her left shoulder and the front driver's side window was shattered. [REDACTED] stated that her and her soon to be ex-boyfriend, Keith Morse, agreed to meet in the area of Route 9 and Bamerry Ln to retrieve some of her belongings from him. [REDACTED] stated that when she arrived in the area, three(3) unknown black females were walking down the street while yelling at her. She stated that the females then approached her vehicle and one of the females punched her driver's side window causing it to shatter. [REDACTED] then stated that she immediately drove away and parked in the parking lot of 1685 Route 9. [REDACTED] further declined medial treatment from TR Med Unit while on scene. [REDACTED] had no further information regarding the females identity or where they resided. It should be noted that [REDACTED] stated that Keith was not involved in this altercation.

[REDACTED] stated that she could not get in contact with Keith after the altercation and did not know his whereabouts. A search of the area yielded negative results for the females or Keith. During the altercation, [REDACTED] two children [REDACTED] and [REDACTED] were inside the vehicle in the rear passenger seats. Both children were not injured during this incident. I subsequently contacted DCP&P and advised them of the incident, they advised that a screener will follow up with [REDACTED] at a later date. [REDACTED] did not want any further police involvement and continued to request to return to her residence. She was advised to contact this agency should she have any further information regarding this matter. Nothing further at this time.
