145 Crash Description/Narrative

D2 states that he was traveling in the middle lane of Route 1 SB/Grandview when he was struck in the rear by V1. Upon making contact with the occupants of V1, Ptl. Eckert and I (Ptl. Richard) could smell alcohol emanating from both persons. Upon speaking with D1 of said vehicle, he states that he was traveling on Route 1 SB, approaching the intersection of RT 1/Grandview when he observed V2 stopped at the green light at said intersection. D1 states that he attempted to slow his vehicle but due to the weather conditions, he slid into the rear of V2. Both parties from V2 reports of complaint of pain and were offered medical attention to which they refused and stated that if needed, they will seek their own medical attention at a later date.

Upon further investigation, D1 (Robert Bertucci) of V1 was placed under arrest for suspicion of Driving Under the Influence (DUI) and transported to headquarters where he was booked and processed accordingly. See this Officer's I.R. (#18077148) for further information regarding this matter.
