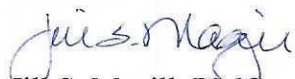

Summary

On 11/4/2020 at approx. 1644 hrs I was stopped facing East at the red light on Grove Ave at the Intersection of Crown Point Rd. I observed the light turn green and proceeded into the intersection. I had to abruptly stop as I observed a large dump truck hauling a trailer traveling at a high rate of speed through the red signal from southbound Crown Point Rd and make a left onto Grove Rd. I conducted a motor vehicle stop on the vehicle , NJ XDBU27, and made contact with the driver, Robert F. Grund. I advised Grund of the reason for the stop and he stated that he could not see the signal due to the sun glare. I advised him that if that was the case, it is his obligation to slow his vehicle and proceed to the Intersection with caution. Grund was issued a summons for failure to observe the traffic signal.
