THE VICTIM RESPONDED TO POLICE HQ TO MAKE A REPORT OF A THREATENING PHONE CALL HE RECEIVED ON 1/29/22 AT 525 PM. THE 24 MINUTE CALL WAS MADE BY RAVI SACHDEV A REPUBLICAN FROM SADDLE RIVER NJ. THE OFFENDER CALLED THE VICTIM WHOM IS RUNNING FOR TOWN COUNCIL IN LIVINGSTON, NJ. THE VICTIM IS RUNNING AS A DEMOCRATIC PICK, AND WAS TOLD THREE TIMES "HIS PERSONAL REPUTATION WILL BE SPOILED IF HE CONTINUES TO RUN AGAINST ROSARIO BAGOLI IN RELATION TO THE TOWNSHIP COUNCIL POSITION." THE CALL WAS MADE FROM [REDACTED] AND WAS NOT RECORDED. IT WAS ALSO NOTED TO CROSS REFERENCE THIS INCIDENT WITH 22-5741 WHERE THE OFFENDER ALSO MADE A SIMILAR CALL TO DIFFERENT TOWN RESIDENT ABOUT THE SAME POLITICAL AGENDA. THE COMPLAINANT FELT THE CALL THREATENING IN NATURE, AND WILDLY INAPPROPRIATE. I SUPPLIED HIM WITH A VOLUNTARY STATEMENT FORM HE WILL RETURN AT A LATER DATE.
