With regard to # 2- the attached records are being provided in their entirety and are responsive to your request.

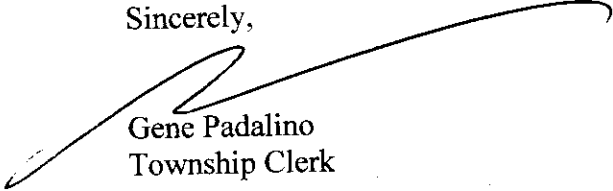

The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
