On the above date and time, I, Ptl. Miserendino #285, responded to a reported disturbance at 149 Brindletown Rd. Upon arrival, I spoke with Danilee Watkins, who explained that one of his employees, Wayne Giquinto Jr., had been hired by sub-lessee Michael Keys Jr. to repair a fence at the back of the farm. Mr. Watkins reported that while Wayne was working, other tenants, Tina and Roy Vega, began harassing him and demanding that he leave. Mr. Watkins stated that Roy confronted Wayne aggressively, recording him with his cell phone.

I also spoke with Wayne, who confirmed that he had been hired by Michael Keys Jr. to repair the fence and had been working on it for the past five days. Wayne described how Roy approached him, harassed him, and became aggressive in trying to force him off the property. The farm's owner, Albert Canka, was also present and stated that he was unaware of anyone being hired to work on the fence. Mr. Canka requested that in the future, Michael Keys Jr. notify him in advance if any construction or repairs are planned on the property. No further police action was taken at this time.
