Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On August 25th 2025 at approximately 1928 hours, I responded to District 1 for a civil matter call.

Upon my arrival, I met with the victim, [REDACTED] in the lobby. [REDACTED] advised that she has been abused verbally and physically by Saheen Bahlouli who is her ex-boyfriend and father of her daughter. [REDACTED] explained that Saheen was released from jail approximately 6 weeks ago and has started living un-welcomed back in her apartment for the past two weeks. [REDACTED] advised she lives at [REDACTED] and this is where these assaults have occurred.

[REDACTED] states that on today's date at approximately 1400 hours, she returned home from work to find Saheen highly intoxicated and argumentative. [REDACTED] states that Saheen had two friends in the house who she did not agree to have there. [REDACTED] explained to Saheen that she was tired from work and wanted to shower and relax. [REDACTED] explained that Saheen began to verbally abuse her by saying things like "fuck you you fat bitch" and "I don't give a fuck about what you want." While Saheen yelled at [REDACTED] she looked at one of his friends and this is when he became jealous and more agitated and continued screaming saying derogatory things about her liking black men. [REDACTED] states this is when Saheen stood up, says "fuck this" and walked over to her and pushed her against a bookshelf. [REDACTED] states Saheen then punched her in the left side of her face causing the inside of her mouth to bleed. [REDACTED] showed me the inside of her mouth and I observed her to have cuts on the inside of her cheek and lower lip. [REDACTED] had a small bruise to the bottom left side of her lip and complaint of pain to her jaw and face.

[REDACTED] further advised that this is not the first time that Saheen has become violent. [REDACTED] explained that this verbal and physical abuse has been happening for the past week. [REDACTED] advised of two other occasions where she was assaulted by Saheen and had bruises in result of it. [REDACTED] first advised that approximately one week ago, Saheen placed her in a headlock during an argument. [REDACTED] advised that she had difficulty breathing and uncomfortableness. [REDACTED] states the second time was on Saturday 8/23/25. [REDACTED] advised that on this date her and Saheen had been arguing and during this argument he punched her in an upper cut style to her chin. [REDACTED] showed me a bruise to the right side of her chin. [REDACTED] also advised that Saheen placed her in a headlock again.
