**AN ORDINANCE FIXING THE SALARIES AND WAGES FOR THE DEPARTMENT OF
PUBLIC WORKS OF THE BOROUGH OF GARWOOD, IN THE COUNTY OF UNION,
STATE OF NEW JERSEY.**

WHEREAS, said ordinance reflects changes of salaries and/or hourly rates to be paid to said employees of the Borough of Garwood for the year 2021.

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of the Borough of Garwood that the proper officer or officers of the Borough be and they are hereby authorized and directed to execute checks on Borough Funds for the purpose of paying the annual salaries and/or hourly rates to the employees of the Borough of Garwood as set forth opposite each job classification. Said salaries to be paid bi-weekly less such deductions as in such cases made. The schedule of salaries hereafter set forth shall be effective as of January 1, 2021.
