**RESOLUTION APPOINTING AN INTERIM BOROUGH ADMINISTRATOR FOR THE  
BOROUGH OF METUCHEN**

**WHEREAS**, due to the resignation of the Borough Administrator, a vacancy was created in the position of Borough Administrator of the Borough of Metuchen ("Borough"); and

**WHEREAS**, the Mayor and Council of the Borough of Metuchen have determined that it is in the best interest of the Borough to appoint an Interim Borough Administrator for the remainder of 2017 to permit the Mayor and Council to publicly advertise and to interview candidates to fill the position of Borough Administrator of the Borough of Metuchen on a permanent basis; and

**WHEREAS**, the Mayor and Council of the Borough of Metuchen deem it in the best interest of the Borough of Metuchen to appoint John Jay Muldoon as the Interim Borough Administrator of the Borough of Metuchen.

**NOW THEREFORE BE IT RESOLVED** by the Mayor and Council of the Borough of Metuchen that John Jay Muldoon is hereby appointed to serve as Borough Administrator of the Borough of Metuchen on an interim basis at a pro rata annual salary of \$115,000.00 and until such time as said position is permanently filled by appointment of the Mayor and Council, however, such appointment shall not to exceed December 31, 2017; and

**BE IT FURTHER RESOLVED** by the Mayor and Council of the Borough of Metuchen that John Jay Muldoon, as the Interim Borough Administrator, shall exercise the full authority provided to the Borough Administrator within the Code of the Borough of Metuchen and by law; and

**BE IT FURTHER RESOLVED** that a copy of this Resolution shall be filed with the Municipal Clerk of the Borough of Metuchen
