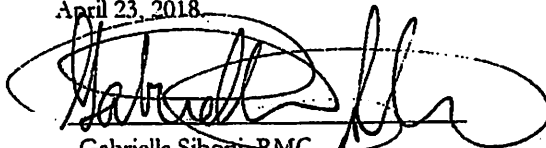
WHEREAS, the Mayor and Borough Council President have recommended the appointments and rates of the following individuals; and,

WHEREAS, Suplee, Clooney and Company offers services and can act as Interim Business Administrator for the Borough of Milltown during the time of search, and;

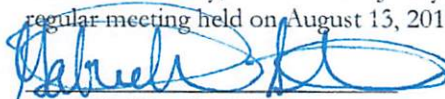

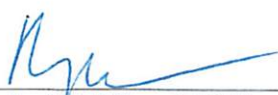

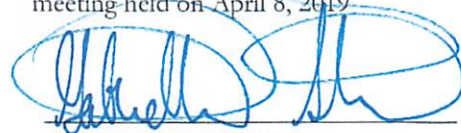
