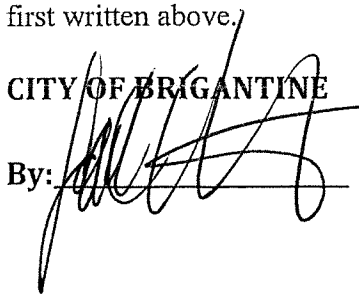
IN EXCHANGE FOR THE MUTUAL PROMISES as hereafter set forth, it is agreed as follows:

Ruderman, Esq.: Two Hundred and Thirty (\$230.00) Dollars per hour, in addition to reasonable out-of-pocket expenses, which hourly rate shall be annually adjusted on written notice to the City in accordance with the schedule of rates established by the Firm for its governmental/management clients.
