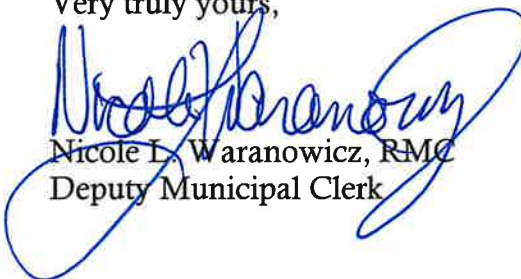

Upon asking Mr. Argudo how can I help him, he advised that he is having suicidal thoughts, thoughts of wanting to harm himself, and also thoughts about harming others. Mr. Argudo advised that he wished to speak to someone at the hospital about the thoughts. At this time, dispatch was advised to have EMS respond to our location to transport Mr. Argudo to the hospital for crisis. Note that Mr. Argudo has a history of mental health issues and has been to the hospital in the past for crisis. This officer asked Mr. Argudo if I could pat him down for weapons, which he willingly complied to, and received negative results for any weapons.

Mr. Argudo's cousin advised that she saw Mr. Argudo walking on Creamer Dr with 2 bags, allowed him into her motor vehicle, and drove him to police headquarters for assistance. EMS then arrived at police headquarters and transported Mr. Argudo to Robert Wood Johnson Hospital for crisis.

Upon the involved parties leaving police headquarters this officer responded to 41 Fanwood Dr to speak with Ms. Quinto. Ms. Quinto advised that she and Mr. Argudo were never involved in an argument, nor did anything physical occur. Ms. Quinto advised that she had a conversation with Mr. Argudo about having AAA tow his motor vehicle, however Mr. Argudo took it upon himself to contact his own tow truck. Ms. Quinto advised that when she returned home, Mr. Argudo was no longer in the residence. Ms. Quinto stated that in the past, Mr. Argudo will leave without telling anyone where he is going. Ms. Quinto advised that Mr. Argudo had previously walked himself to Perth Amboy Hospital for crisis and in a separate incident a homeless shelter. Ms. Quinto was advised that a report would be generated on the incident and that a copy of the report would be available to pick up at police headquarters. Ms. Quinto was advised to contact police headquarters if we could be of any further assistance to her.

Officer Report Narrative		
On December 21, 2023, I, Ofc. Tesar responded to the area of 423 Main St in reference to a welfare check. The involved party, Aaron Argudo, had called dispatch looking for information about homeless shelters and was possibly in route to Perth Amboy. A short time later, his family had contacted police stating that he was having a mental health episode and left the residence and they were concerned about his well being. I was familiar with Aaron having previously dealt with him and his family recently. A search of the last known location of area yielded negative results. Sgt. Maslowski located him a short time later walking down Main St. in the area of White Oaks Dr. Aaron advised that he was on his way to Perth Amboy as previously stated. I then arrived at his location to assist. He did not appear in distress or having any mental issues at this time. He was polite and cooperative as we advised him we would provide him with a transport to the shelter. He was patted down for weapons by Sgt. Maslowski and then placed in the rear of Car 36. I then gave him a courtesy transport over to the community center in Perth Amboy and turned over to their staff without incident.

Officer Report Narrative On December 12, 2023, I, Ofc. Tesar along with Ofc. Zuczek responded to 41 Fanwood Dr for a family verbal dispute. While en route, dispatch advised that the call was only verbal and involved her 19 year old autistic grandson. Upon arrival, we made contact with Louise Quinto and her grandson, Aaron Argudo and spoke to them about their current situation. Louise described that Aaron has been high strung and argumentative in recent weeks. I continued to question her on the the specific topic but was given a vague answer concerning Aaron attending Epic Church and him possibly pushing his beliefs onto them constantly. During my conversation with her, Aaron would continually interrupt or interject during every statement she made. She then advised that she would try to walk away but he would just follow and continue. He eventually then blocked her on the stairs and put his hands up to block and push her back from walking, which prompted her calling the police. I then spoke to Aaron and explained to him how his demeanor and constant arguments are unwelcomed. He advised that he did not push or block Louise and that she was also argumentative towards him as well. Both parties advised that they would remain separate and attempt to go to bed and resolved the issue at a later time. Nothing further at this time.

145. Crash Description/Narrative

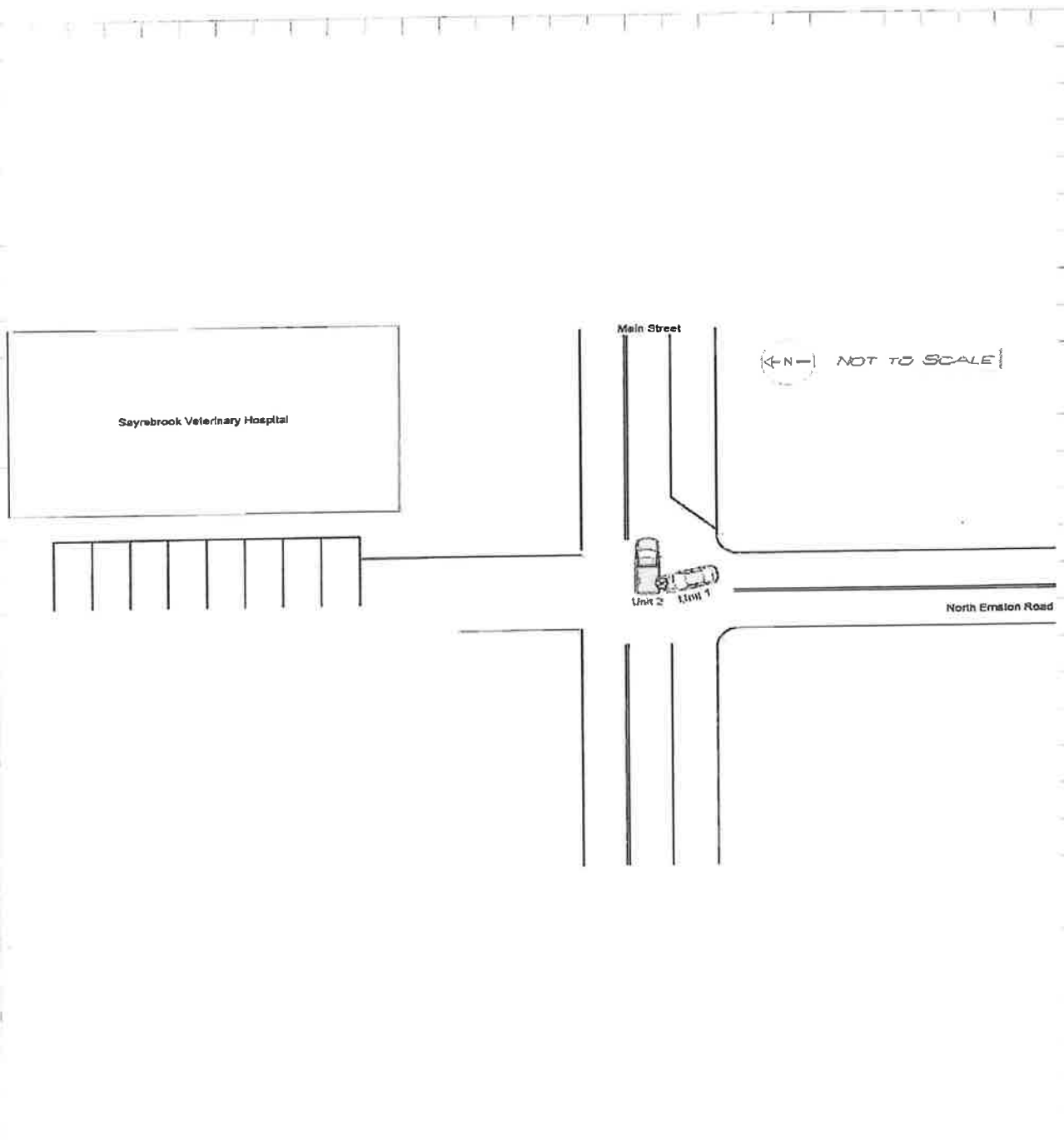

Officer Report

John Quinto, Louise Quinto and Ciara Quinto were all transported to RWJ Hospital via Sayreville EMS for further medical treatment due to smoke inhalation.

The remaining family members advised they would be going with a family member to 52 Kendall Drive if they needed to be contacted.

During the fire multiple vehicles located in the front of the residence were damaged by the flames (NJ REG#K62LTH, NJ REG#J41RCJ, NJ REG#S11RVB).

Fire Marshall Kevin Krushinski advised they would be conducting their investigation later on due to no visibility. I remained on scene to secure the scene until I was relieved by Ptl. Arway.

No further police action was taken.
