**INSTRUCTIONS FOR NOMINATING PETITION
FOR ANNUAL SCHOOL ELECTIONS**

This information sheet is not meant to encompass all the statutory and constitutional requirements for filing petitions but is to be used only as a guide.

1. Completed nominating petitions shall be filed with the Salem County Clerk's Office not later than **4:00 pm, Monday, July 27th**.
2. At least twenty-five (25) signatures shall be required for any petition.
3. A joint petition can have 2 or more candidates as long as each candidate's term is the same and their designation/slogan is the same. A minimum of 25 signatures is needed for a completed petition.
4. The candidate's name, address and office he/she is seeking must be on the petition before circulation. **DO NOT CIRCULATE BLANK PETITIONS.**
5. The circulator of the petition **MUST WITNESS ALL SIGNATURES. DO NOT PASS PETITION TO A SECOND CIRCULATOR – USE A NEW PETITION.**
6. The circulator of the petition must execute the affidavit in Section C. **AFFIDAVIT MUST BE NOTARIZED.**
7. Each candidate must execute the Oath of Allegiance in Section D. **AFFIDAVIT MUST BE NOTARIZED.**
 - a. Candidates are respectfully asked to have their petition notarized prior to returning it and to seek notarization from a notary outside of the office where the petition is being submitted. This helps maintain impartiality and ensures a smooth and efficient filing process.
8. The Petition must be signed by legally qualified voters (of any party) residing in the County of Salem, and in the Municipality for their respective School Board.
9. Each registered voter can only sign one time for the same candidate and cannot sign more petitions than seats available.
10. A candidate can sign his/her own petition and be the circulator.
11. Pursuant to P.L. 2018, ch. 66, all candidates for any public elective office must include a functioning email address on their petition of nomination.

DESIGNATION: (Optional. No more than 3 (three) words that convey the principles which the candidate represents, but no designation may contain the name, or a derivative or any part thereof, used as a noun or an adjective, of any political party that is entitled to participate in a primary election. NJSA 19:23-17)

QUALIFICATIONS - Candidates filing a nominating petition for board membership must meet the following qualifications:

- A citizen of the United States of America
- At least 18 (eighteen) years of age to qualify for office
- Able to read and write
- A resident of the district, or of such constituent district of a consolidated or regional district as may be required by law, from which he/she is to be elected for at least one year preceding the date of the election
- Not disqualified as a voter pursuant to *N.J.S.A. 19:4-1*
- A registered voter in the district
- Not convicted of a disqualifying crime pursuant to *N.J.S.A. 18A:12-1*

No Board of Education member shall be directly or indirectly involved in any contract with, or claim against, the board.

IMPORTANT INFORMATION

- Within 30 days of election or appointment to the board, a member must undergo a **criminal history background investigation** through the New Jersey Department of Education.
- The School Ethics Act and nepotism legislation impact the ability of board members who have relatives working in the school district to act in areas such as personnel and collective negotiations. Please consult your Board Secretary for details.

Complete nominating petitions shall be filed with the Salem County Clerk's Office on or before 4:00 p.m., Monday, July 27th, 2026.
