- not disqualified as a voter pursuant to N.J.S.A. 19:4-1
- a registered voter in the district
- not convicted of a disqualifying crime pursuant to N.J.S.A. 18A:12-1

the board. **IMPORTANT INFORMATION**

- Within 30 days of election or appointment to the board, a member must undergo an investigation through the New Jersey Department of Education.
- The School Ethics Act and nepotism legislation impact the ability of a board member to act in areas such as personnel and collective negotiations.
- Two or more candidates for any given term of office may notify in writing, drawing date that they wish to have their names with their chosen designation, if any, are selected as a group at the drawing and their names shall be placed on the ballot. The candidates shall determine among themselves the order in which they will appear on the ballot to so notifying.
