- a registered voter in the district

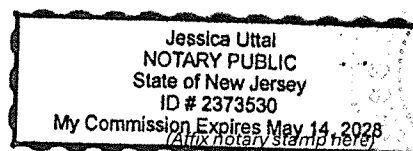

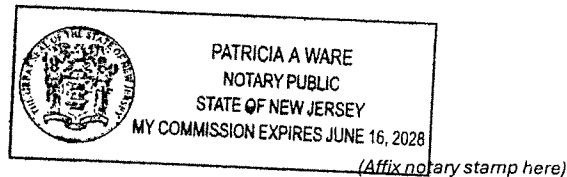
