MS. BROWN'S ACTIONS WERE IN VIOLATION OF 2C:5-2.A.1.

BROWN ACTIVATED A TCL BRAND SMART PHONE, MODEL NUMBER A501DL, FOR THE PURPOSE OF BEING UTILIZED BY INDIVIDUALS SHE KNEW TO INCARCERATED IN THE MONMOUTH COUNTY CORRECTIONAL INSTITUTION. MS. BROWN ALSO PROVIDED THE PHONE TO MR. STEINMETZ FOR THE PURPOSE OF DELIVERING IT TO INMATES WHILE HE WAS WORKING IN THE MCCI. MS. BROWN'S ACTIONS WERE IN VIOLATION OF 2C:29-10.C.

Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

A TCL brand smart phone, model number A501DL and IMEI Number 015293006970887 was recovered from the toilet of Cell 110 in Housing Unit A-1. The cell was occupied by inmates (I/M) Hall, Taques (DOB 22 AUG 92) and West, Jubri (DOB 16 OCT 99) and was secured with both inmates inside the cell at the time of recovery. Recorded phone conversations between Ms. Brown and I/M Roberts revealed that she procured, activated and delivered the phone at the direction of I/M Roberts. Additionally, Mr. Steinmetz identified Ms. Brown as the individual that gave him the phone.
