The Division of State Police is in receipt of your OPRA request.

You will be provided the following records under OPRA:

- Complaint Summons and Affidavit

You will note, redactions of the above record had been made to omit personal identifying information (pursuant to N.J.S.A. 47:1A-1.1 and R. 1:38-7).

We have located Investigation Report #B150-2020-00383, however, your request for same, as well as dash camera video footage and search warrant are denied as it is a request for Criminal Investigatory Records. Criminal Investigatory Records are specifically exempt from public access under the Open Public Records Act, N.J.S.A.47:1A-1, et. seq. and N. Jersey Media Group v. Twp. of Lyndhurst, 229 N.J. 541, 569 (2017). OPRA defines criminal investigatory records as any "record[s] which [are] not required by law to be made, maintained, or kept on file that [are] held by a law enforcement agency which pertains to any criminal investigation or related civil enforcement proceeding." N.J.S.A. 47:1A-1.1.

Notwithstanding our denial above, we are providing you the NJSP Arrest Report that was generated under the same case number. You will note, redactions of the above records had been made to omit personal identifying information (pursuant to N.J.S.A. 47:1A-1.1) and R. 1:38-7).

Regarding your request for "body cams", we have located video recordings with audio from multiple cameras with a total of over 6 hours of video footage. Providing 6 hours of video recordings with audio, would substantially disrupt agency operations. In order to more quickly expedite this process and to provide you with records, we require that you narrow the scope of your request for body cam footage. This request to narrow your scope is not a denial of access to the records sought, if you wish to discuss this part of your request, please call us at 609-671-7913 or email us at xxxxxxxx@xxxx.xxx.

The Division reserves the right to claim additional grounds for denial not raised in this response.
