Good Citizen,

The Division of State Police is in receipt of your OPRA request.

Your request for "A list of names of ALL NJ State Police Troopers of all ranks including but not limited to SGTs, LTs, and above, who were assigned to the NJ Sate Senate Judiciary Committee Hearing on the date of Thursday February 20th, 2025, between the hours of 10am-6pm. All names of troopers who were inside the Senate Committee Chambers.", is denied, as it is asking for information and therefore is improper under OPRA. OPRA is a records law, not an information law. See MAG Entm't, LLC v. Div. of Alcohol Beverage Control, 375 N.J. Super. 534(App. Div. 2005). Also see Gannett New Jersey Partners, LP v. County of Middlesex, 379 N.J. Super. 205(App. Div. 2005): "OPRA requires a party requesting access to a public record to specifically describe the document sought.

Notwithstanding the above denial, as a courtesy, you will be provided with NJSP Cad Abstract #C420/2025-00224983 as it may contain the information you seek.

You will note, redactions of the above record have been made to omit personal identifying information and to protect the reasonable expectation of privacy (pursuant to N.J.S.A. 47:1A-1.1 and R. 1:38-7). Also note, the MSI Return & Access Log (pages 4 -8) on the Computer Aided Dispatch (CAD) Abstract, which detail all computerized criminal and motor vehicle look up information were withheld, consistent with N.J.A.C. 13:59-1 et seq.

The Division reserves the right to claim additional grounds for denial not raised in this response.

Accordingly, your request is now considered Filled Closed.
