The Carteret Police Department is in receipt of your request for records pursuant to the Open Public Records Act (NJSA 47:1A-1) dated, July 26, 2021. The Carteret Police Department Official Records Custodian, Captain Jeffrey VanWoeart received your OPRA request on July 28, 2021. As such, the seven (7) business day deadline to respond to your request is August 4, 2021. This response is being provided on the third (3rd) business day since the receipt of your request.

The following specific records have been requested:

I would like a copy of all police reports filed at the school dedication ceremony on September 29, 2020 I would like a copy of all CAD reports from September 29, 2020 from 9 am to 8 pm

I would like a copy of all radio transmissions for the police department from September 29, 2020 from 9 am to 8PM

I would like a copy of the police payroll records and time sheets for September 29, 2020

I would like a copy of all complaints and witness statements for any incidents occurring on September 29, 2020 I would like a copy of Patrolman Shah's body camera footage from September 29, 2020 from 8 am to 8 pm

I would like a copy of all memorandum's or information disseminated by (or at the direction of) a shift or squad commander. on September 29, 2020

Records responsive to this request .

I would like a copy of all police reports filed at the school dedication ceremony on September 29, 2020 I would like a copy of all CAD reports from September 29, 2020 from 9 am to 8 pm Investigation Reports # I-2020-054180 and 054189 have been located. These records are criminal investigatory records, and such are exempt from release under OPRA. Pursuant to NJSA 47:1A-1.1, criminal investigator records are "records which are not required by law to be

made, maintained or kept on file that are held by a law enforcement agency which pertain to any criminal investigation or related civil enforcement proceeding.” Therefore your request is denied. CAD reports from September 29, 2020 from 9 am to 8 pm have been located and supplied. Redactions have been made considering the principles of law listed below :

Executive Order No. 21 (McGreevey 2002)

Records where inspection, examination or copying would substantially interfere with the State's ability to protect and defend the State and its citizens .

N.J.S.A 47:1A-1.1 Administrative or technical information regarding computer hardware, software and networks which, if disclosed would jeopardize computer security.

Emergency or security information or procedures for any buildings or facility which, if disclosed, would jeopardize security of the building or facility or persons therein.

Security measures and surveillance techniques which, if disclosed, would create a risk to the safety or persons, property, electronic data or software.

N.J.S.A 47:1A-1 Privacy Interest – a public agency has a responsibility and an obligation to safeguard from public access a citizens personal information with which it has been entrusted when disclosure thereof would violate the citizens reasonable expectation of privacy.

2C:25-33A(7) Uniform record of applications for relief ; information included, confidentiality. All records maintained pursuant to this act shall be confidential and shall not be made available to any individual or institution except as otherwise provided by law

I would like a copy of all radio transmissions for the police department from September 29, 2020 from 9 am to 8PM .These records are criminal investigatory records, and such are exempt from release under OPRA. Pursuant to **NJSA 47:1A-1.1**, criminal investigator records are “records which are not required by law to be made, maintained or kept on file that are held by a law enforcement agency which pertain to any criminal investigation or related civil enforcement proceeding.” Therefore your request is denied. This request has produced a voluminous record. Please refine your search so the records can be properly stored under the laws of OPRA.

I would like a copy of the police payroll records and time sheets for September 29, 2020. The police payroll has been located and supplied. Timesheets ,No record responsive to this request have been located, for this reason, at this time your request is denied.

an individual's name, title, position, salary, payroll record, length of service, date of separation and the reason therefor, and the amount and type of any pension received shall be a government record; personnel or pension records of any individual shall be accessible when required to be disclosed by another law, when disclosure is essential to the performance of official duties of a person duly authorized by this State or the United States, or when authorized by an individual in interest; and data contained in information which disclose conformity with specific experiential, educational or medical qualifications required for government employment or for receipt of a public pension, but not including any detailed medical or psychological information, shall be a government record.

I would like a copy of all complaints and witness statements for any incidents occurring on September 29, 2020. **Baffi Simmons and the African American data and Research Institute v. Wendy Mercado, City of Millville, Millville Police department (APP Div. 2020)** Complaint-summons are documents that are completed via the state's Electronic Complaint Disposition Record (ECDR) system, "and the finished product is maintained by the municipal court or, in a larger sense, the judiciary." Requests must be directed to the judiciary for production of such records. **Statements : North jersey media Vs. Lyndhurst:** witness statements are records which are not required by law to be made, maintained or kept on file that are held by a law enforcement agency which pertain to any criminal investigation or related civil enforcement proceeding. are exempt from release under OPRA. Therefore your request is denied.

I would like a copy of Patrolman Shah's body camera footage from September 29, 2020 from 8 am to 8 pm. No record responsive to this request have been located, for this reason, at this time your request is denied

I would like a copy of all memorandum's or information disseminated by (or at the direction of) a shift or squad commander. on September 29, 2020. No record responsive to this request have been located, for this reason, at this time your request is denied.

MAG Entm't, LLC v. Div. of Alcohol Beverage Control, 375 N.J. Super. 534 (App. Div. 2005): The Court held that "[w]hile OPRA provides an alternative means of access to government documents not otherwise exempted from its reach, *it is not intended as a research tool litigants may use to force government officials to identify and siphon useful information. Rather, OPRA simply operates to make identifiable government records 'readily accessible for inspection, copying, or examination.'*" *N.J.S.A. 47:1A-1.*" (emphasis added). The Court further held that "[u]nder OPRA, agencies are

required to disclose only 'identifiable' government records not otherwise exempt . . . In short, OPRA does not countenance open-ended searches of an agency's files." Id. at 549 (emphasis added). *Bent v. Stafford Police Dep't*, 381 N.J. Super. 30 (App. Div. 2005): The Court affirmed the GRC's decision (GRC Complaint No. 2004-78) that the complainant's request was broad and unclear ("any and all"). The Council ruled that the information sought did not amount to an identifiable government record.

NJ Builders Assoc. v. NJ Council on Affordable Hous., 390 N.J. Super. 166, 180 (App. Div. 2007): The requestor submitted a 5 page document listing 38 separate requests, all of which included a request for "any and all documents and data used or considered . . . supporting, demonstrating, justifying or verifying" various determinations relevant to COAH's determinations about fair-share housing obligations. The Court held that the requestor did not specifically identify the records sought, as required by N.J.S.A. 47:1A-5(f), and OPRA did not require the custodian to produce the records within seven (7) business days pursuant to N.J.S.A. 47:1A-5(i).

Schuler v. Borough of Bloomsbury, GRC Complaint No. 2007-151 (Interim Order dated December 19, 2007): The Council held that "[b]ecause the Complainant's OPRA requests #2-5 are not requests for identifiable government records, the requests are invalid and the Custodian has not unlawfully denied access to the requested records pursuant to *MAG Entm't, LLC v. Div. of Alcoholic Beverage Control*, 375 N.J. Super. 534 (App. Div. 2005) and *Bent v. Stafford Police Dep't*, 381 N.J. Super. 30 (App. Div. 2005)." Id. at 9.

If you are requesting under common law, you must articulate your legal interest in the subject matter contained in the material, then the material may be disclosed if under a balancing test your right of access outweighs the states interest in preventing disclosure. Please articulate your legal interest.

If your request for access to a government record has been denied or unfilled within seven (7) business days by law, you have the right to challenge the decision by the Carteret Police Department to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint form.
