Investigation Narrative

At approx. 2351 hrs. on 7/20/20 this officer along with Cpl. Tye, #277, were conducting a area check of the Docksider Condominiums when this officer observed a strong smell of burnt marijuana coming from one of the units. After narrowing the smell down to a specific area it was determined that the odor was coming from the rear deck of unit 822. This officer and Cpl. Tye proceeded to this unit which was located on the second floor of Building "B". This officer knocked on the door and a female, later identified as Tempastt Ortiz, opened the door. This officer asked if she was the owner of the unit and she stated that she was leasing the unit along with her boyfriend. I asked the tenant if we can come in to talk with her and she proceeded to open the door and allowed us into the unit. Once inside the unit it was obvious that a strong smell of raw/burnt marijuana was coming from this specific unit. As we entered the unit a male subject came towards the door and asked why we were inside of the unit. This officer advised the subject that the tenant allowed us to come in and she confirmed this to him as well. The male subject, identified as Ricky Browner, was uncooperative initially and stated that he was also a tenant on the lease. This officer advised both tenants that as I was walking around the complex I detected a strong smell of burnt marijuana coming from the unit. I also advised both tenants that there have been numerous complaints from neighbors of the strong odor of the burnt marijuana and that was the reason for us checking the area. There was nothing obvious or visible in the open area of the unit of any illegal drugs/paraphernalia but we advised the tenants that upon entering the unit it was evident the smell was coming from this specific unit. After a few minutes speaking to both tenants they agreed that they will no longer smoke on the deck located on the rear exterior of the property and understood the possible implications of continuing to do so. Both parties were cooperative and advised that their lease is ending the end of August and will be relocating at that time. No further information.
