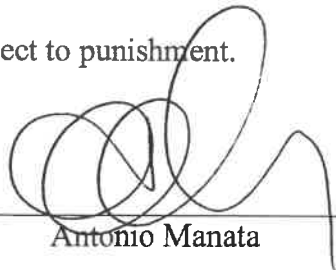
## **CERTIFICATION OF ANTONIO MANATA**
