Supplemental Investigation Report



On 21 July 2021 I assisted Patrolman Peter Hand #94 with an investigation of an alleged unlawful use of a credit card/ credit card fraud. The suspect in this matter is identified as Angela Heron and the victim is identified as Dawn Garrison. Garrison had noticed a \$561.00 dollar charge to her Citizen bank card which she did not authorize. This charge was made for the Twilight Motel, 210 East Spencer Avenue. Refer to Ptlm. Hand's completed investigation report for further details.

I conducted a formal video recorded interview with Angela Heron in interview room #2. Refer to the corresponding DVD-R maintained in the case file for the full and complete statement given by Heron.

In sum, Heron stated that she reserved a room at the Twilight Motel using the website "Booking.com". She stated that she entered her bank card account number and expiration date at the time she reserved the room. She selected the option to pay for the room upon arrival at the motel. Upon arriving, Heron explained that she presented her Citizen Bank card to complete the transaction. She further stated that she did not purposely enter a different account number on the web site and did not intend to defraud anyone.

At the conclusion of the investigation, Heron was released with no charges.

Incident Report



On the above date and time, I, Patrolman Peter Hand #94 of the Wildwood Police Department responded to 210 E Spencer Avenue (Twilight Motel) for a report of a credit card theft. Upon my arrival I met with the caller, Kathleen Mangini, the manager for the Twilight Motel. Mangini advised me that she received a call from a Dawn Garrison prior to her calling 911. Mangini stated that Garrison reported that her credit card was used without her consent or knowledge at the Twilight Motel. I contacted Dawn Garrison via phone on scene. Garrison stated that she was notified by her bank (Citizens Bank) that a fraudulent charge was detected.

Garrison stated the charge was in the amount of \$561.10 at the Twilight Motel in Wildwood NJ. Garrison advised me that she is in Philadelphia and has not visited Wildwood recently. Garrison stated that the charge was not authorized by her and she was unaware of the charge until the bank contacted her. Garrison provided her contact information and I provided her with a case number. Garrison also stated that she has possession of her the card and is unsure how it was used by another person. Garrison advised me that she did use it at a gas station a few days prior. Garrison stated that no other fraudulent charges were made with her card.

Kathleen Mangini, provided me with a receipt which was later attached to digital media. Mangini stated that the suspect's name is Angela Heron and is staying in room #121. I attempted to make contact with Angela Heron in room #121 however was unable to make contact at the time.

Kathleen Mangini called police at approximately 1348 hours and stated that the suspect had returned to the room. Patrolman Rosetti #547 responded and made contact with Angela Heron. Heron was detained and transported to police headquarters for investigation purposes.

I returned to the Twilight Motel and booking.com was contacted on scene. It was discovered that booking.com does not require a credit card security code, name, or address and/or zip code when using the web site. The credit card number and expiration date are the only required fields as per booking.com customer service agent "Margaret #1602". After acquiring this information I returned to police headquarters.

Angela Heron had in her possession a Citizen's bank card with an expiration of 03/24. The victim's card was a Citizen's bank card ; with an expiration of 03/24. Note that the two cards are very similar. This information was relayed to Detective Division and a formal statement was conducted shortly after (See supplemental regarding the statement with Detective Division).

Angela Heron was ultimately released after confirming that the unauthorized charge was done in error by Heron while she was utilizing the booking.com web site. I relayed Heron back to the Twilight Motel where she met with the manager, Kathleen Mangini. Heron paid the outstanding room balance and the call was cleared.

The victim, Dawn Garrison, was notified of this information and provided with the case number and how to obtain the report.
