It is understood and agreed that this settlement is in full compromise of a disputed claim as to all issues by and between the parties and that neither this Release nor the payment pursuant thereto shall be construed as an admission of liability, such being denied.

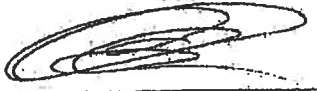

Lavallette, its employees, officials, whether elected or appointed, its agents, servants and assigns, Qual-Lynx and the Ocean County Joint Insurance Fund regarding Medicare / Medicaid rights to recovery known as of this date.

By the Releasor executing this Release, the Releasor understands that she can make no further claims.

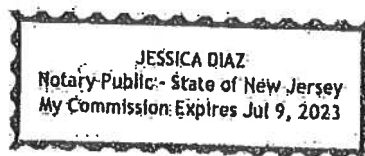
