Good day,

The Ocean County Sheriff's Office received your Open Public Records Act (OPRA) request on or about October 1, 2018. The official Records Custodian, Lt. Joseph Greene, received your OPRA request on October 1, 2018. As such, the seven (7) business day deadline to respond to your request is October 10, 2018. This response to your request is being provided to you on the 6th business day after the custodian's receipt of said request.

The following records were requested:

" 1- Copies of all CAD reports/comments/Spillman entries listing Ocean County Sheriff's Department responses/calls for service & personnel present at the days Hotel, 290 Route 37 Toms River, NJ 08753 on September 29th, 2018. "

This request is denied under the following exemption to the OPRA requirement:

N.J.S.A. 47:1A-1.1

- 10) Emergency or security information or procedures for any buildings or facility which, if disclosed, would jeopardize security of the building or facility or persons therein.
- 11) Security measures and surveillance techniques which, if disclosed, would create a risk to the safety or persons, property, electronic data or software.

However, without waiving any objections and in the spirit of cooperation, I can provide you with the following information:

The Ocean County Sheriff's Office provides security for all Congressional member who request it for events held within Ocean County. This event incurred no overtime.

This response is being communicated with you via e-mail per your request.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Ocean County Sheriff's Office to deny access.

You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
